



PRESIDENT'S MESSAGE

LOOKING AHEAD





PRESIDENTDr. Amr M. Moursi

In 1909, Dr. Minnie Evangeline Jordan opened what is considered the first dental practice exclusively caring for children. The notion that oral health care for children was different than that for adults took a while to catch on but it eventually it did, thanks to pioneers like Dr. Jordan and others. So much so, that in 1947 The American Academy of Pedodontics was formed. And now, re-named the American Academy of Pediatric Dentistry, we are celebrating our 75th anniversary. The handful of dentists who founded the Academy would be amazed at what has grown out of that small group they created, and the impact it has had on the children of the United States and the world.

Our new 75th anniversary book has much more on the history of the Academy. To look through our history is to gain a newfound respect for all the work of those who preceded us. This includes Dr. Jeannie Beauchamp, our Immediate Past President. She led us with such grace through the difficult journey of this last year as we emerged from the depths of the pandemic to

the beginning of some normalcy. The dedication of our leaders, both distant and recent, makes serving as your President even more of an honor and privilege. As I start my term, I hope to use my experience as a practicing pediatric dentist, a teacher and a researcher to move our Academy forward over this next year with renewed energy.

Those of you who joined us in San Diego for our first in-person Annual Session in three years felt that re-energized spirit first-hand. With more than 5,500 attending it felt more like a revival than a dental meeting! It was reassuring to see that the vitality and passion of the Academy was not at all dimmed by our forced absence. In fact, for many it was an opportunity to re-appreciate the special culture we have among our pediatric dentistry family. There were innovative and cutting-edge scientific presentations and over 450 research posters presented. The many volunteers on our Councils and Committees continued all their hard work. But we also had all that during the highly successful virtual Annual Sessions in 2020 and 2021. The



special ingredient, the secret sauce if you will, that was missing was what happens outside the "meeting rooms". Reunions with former classmates and old friends, chance meetings in the exhibit hall or coffee shop, all simply impossible on a laptop. And of course, the wonderful social events, including a phenomenal Welcome Reception in the Gaslamp District sponsored by the AAPD Foundation. A special thanks to Local Arrangement Chairs, Drs. Jacob and Aaron Lee, the Scientific Program Committee, led by Dr. Anthea Mazzawi, and the amazing staff in our Meetings and Continuing Education Department.

At the Annual Session, although we did not want the pandemic to define us, it was important that we recognized what we have missed. The residents who graduated in 2020 and 2021 faced substantial challenges and missed out on many experiences, including the opportunity to attend an in-person Annual Session as a resident. This is usually the first introduction most of us have to the Academy and an excellent opportunity to experience the unique personality of our specialty.

So, the classes of 2020 and 2021 were offered complimentary registration to this year's Annual Session and nearly 400 took advantage of this offer to join us in San Diego. We also took time to recognize, in a very special reception, the Academy Presidents that guided us through the depths of the pandemic, Drs. Kevin Donly (2019-20) and Jessica Lee (2020-21). They expertly navigated the swirling challenges of the global pandemic with our Academy's Mission as their guide.

Looking ahead, we will continue to focus on the most pressing issues facing pediatric oral health. This includes our efforts to address limited access to operating rooms through advocacy with the Centers for Medicare and Medicaid Services, and supporting children with congenital anomalies though passage of the Ensuring Lasting Smiles Act. We will also continue to address the critical issues facing our members' ability to provide care, such as severe workforce shortages, and the ever-increasing student debt incurred by many of our early career pediatric dentists. We will also continue to support leadership development and diversity, equity and inclusion (**DEI**). The current cohort of the Advanced Leadership Institute has been tasked with a focus on DEI, following on from the AAPD 2020-21 DEI Task Force. Their goal is to provide recommendations for efforts that can make all members feel welcomed and give everyone a meaningful voice, as well as ensure that the care we provide meets the AAPD Vision: Optimal oral health for ALL children.

As Dr. Beauchamp said in her last President's Message, collaboration and focus are the keys to our success. It is a great honor and also a great responsibility to lead the Academy. But, your leaders are here to represent you, and the children we all serve, so please let us hear from you. Your collaboration will help guide us as to where we should place our focus. I would like to thank all the AAPD staff and the many volunteers who often go unrecognized as they help make this Academy such a special place to call our professional home. I know that our founders, those 75 years ago, would be very proud.

REQUEST FOR NOMINATIONS

NORTHEASTERN AND SOUTHEASTERN DISTRICTS

The AAPD is accepting nominations for trustee positions in two districts. Current Trustees Angela M. Stout (Northeastern District) and Carlos A. Bertot (Southestern District) will rotate off the Academy's board of trustees at the conclusion of the 2023 Annual Session. Nominations for new trustees from the Northeastern and Southeastern Districts, for a three year term of service beginning in 2023 and concluding in 2026, are now being accepted. Nominations must be transmitted to AAPD headquarters from the respective districts for these positions. *The nominations packet must be received at the AAPD headquarters office (to the attention of Margaret Bjerklie). no later than Sept. 1, 2022.* Candidates are therefore urged to send their completed* packet to the respective district by Aug. 14, to allow time for the district to forward the packet.

Nominations can be transmitted in one of two manners:

- Individuals from the Northeastern and North Central districts can submit a nomination by including:
 - A letter signed by ten AAPD voting (Active or Life) members from the district signifying support of the nomination.
 - An AAPD nomination form** signed and dated by the Nominee
- An AAPD state chapter in the Northeastern or North Central district can submit a nomination by including:
 - A letter, signed and dated, from the president of the recognized state chapter certifying that the nomination is an official action of the state chapter.
 - The AAPD nomination form**, signed and dated by the Nominee.

Under either scenario, the completed nomination packet must be forwarded to the respective district organization (Northeastern Society of Pediatric Dentistry President Maxim Sulla or Southeastern Society of Pediatric Dentistry President Christopher L. Maestrello), who will in turn forward these materials to the AAPD headquarters.

The required materials from nominees are the following:

- Completed and signed Nomination form;
- A one-page essay explaining their interest in serving in the specific office and summarizing their leadership skills;
- A background description suitable for publishing in *Pediatric Dentistry Today*;
- A photograph in electronic format suitable for publication in *Pediatric Dentistry Today*;
- Three letters of recommendation from voting members of the Academy.

If two or more candidates are nominated, the AAPD will conduct an electronic ballot of each AAPD voting member in the district in order to select the trustee.

The nominations packet must be received at the AAPD headquarters office (to the attention of Margaret Bjerklie) no later than Sept. 1, 2022.

^{*} Electronic submission is preferred. The required three letters of recommendation should be sent directly to AAPD headquarters (attention: Margaret Bjerklie, mbj@aapd.org); they do not have to be included in the packet submitted to the district chapter or forwarded by the district chapter to AAPD.

The Historic Gaslamp Quarter buzzed with excitement as more than 5,000 members and their families came out to show their BIG LOVE for little teeth!





The AAPD will strictly adhere to these guidelines. All submissions and abstracts must be complete in order to be considered for a session at AAPD 2023, GSRA or a Poster.

Please find a description of each course type below to assist you when submitting for AAPD 2023.

LEARNING LABS

Lead an hour-long interactive presentation on a topic of interest to pediatric dentists (50 minute presentation with 10 minute Q&A). Share your idea with up to 25 colleagues in a smaller setting. AV is available for use during Learning Labs, but the session should focus more on discussing the topic with your attendees. One Learning Lab will be held every hour from 8 a.m. - 5 p.m. on Friday, May 26, and Saturday, May 27. (One hour time commitment per speaker)

MINICLINICS

Miniclinics sessions consists of eight speakers, each with a 45-minute presentation to a larger audience, based on a clinical topic geared toward pediatric dentistry. Areas of interest include early malocclusion management, clinical techniques using new technologies, legal issues, practice management and new developments in pediatric dentistry.

STRING OF PEARLS

A 15-minute presentation per speaker, up to nine presentations per session. In this format, each presenter will bring a single idea or concept and will share it with the group. These little "pearls" provide members with a wealth of information that often can be utilized immediately. Keep your presentation focused on the topic and allow for a question or two from the audience!

INTERNATIONAL ORAL PRESENTATIONS

A 15-minute opportunity with a 10-minute oral presentation and five minutes for questions from the audience. In this format, each presenter will bring a single idea or concept and will share it with the audience. You must be an international pediatric dentist to present during this session. Keep your presentation focused on the topic and be sure to allow time for questions.



Despite the numerous challenges, the AAPD-SC at CUSDM has successfully implemented a series of educational and networking events for dental students interested

The educational series organized by our chapter titled, "How to Get into the Residency of Your Dreams" provided valuable information to help students kick-start their quest. Dr. Elizabeth Shick, Associate Professor of Pediatric Dentistry, led a workshop and provided insights on how to prepare a resume and personal statement. During the workshop future applicants had the opportunity to receive valuable feedback on these important application materials. The second event in this series centered on discussing what pediatric dental residency programs are looking for in applicants. During this event, Dr. Chaitanya Puranik, Director of Predoctoral Education in Pediatric Dentistry at Children's Hospital Colorado, provided the candidates with all the action items to strengthen their applications, increase their chances of receiving interview invitations, and eventually match to their desired program. The third lecture of the series was a panel of fourth year students at CUSDM that applied to pediatric residency programs. The panel answered questions and gave practical advice on the PASS application, interview process, and experience with the MATCH system. The following session was "Do's and Don'ts of Interview" facilitated by the first- and second-year pediatric

dentistry residents from the Children's Hospital Colorado's Pediatric Dentistry residency program. This session also provided attendees the opportunity to learn more about the experiences of pediatric dentistry residents.

The last session involved in-person and online mock interviews. This session was the highlight of the series and was facilitated by our own fourth year dental students who completed their residency interviews. The one-onone mock interviews with prospective applicants was a wonderful experience and was highly appreciated by the AAPD-SC members and participants.

The AAPD-SC at CUSDM also facilitated an environment for members to learn key topics in the field of pediatric dentistry. Evidence-Based Dentistry Update

SUZI SEALE COLL AWARD

Dr. Vineet Dhar was selected for the 2022 Suzi Seale Coll award.

PULP THERAPY

A draft of the primary tooth systematic review/meta-analysis is currently under review by the workgroup. Data extraction of articles is still ongoing for the permanent tooth vital pulp treatment.

BEHAVIOR GUIDANCE

The Behavior Guidance Workgroup will conduct a systematic review in conjunction with the clinical practice guideline. The systematic review is entitled "Non-pharmacological behavior guidance interventions in pediatric dental patients" and is estimated to be completed by mid-2023. The Clinical Practice Guideline is estimated to be complete in mid-2023.

The Behavior Guidance Workgroup is considering the development and distribution of a survey to understand the contemporary behavior guidance techniques used by AAPD members. This survey would not only provide useful data on provider preferences for a practical focus on the clinical guidelines but would offer a valuable informational report/article for members treating patients needing well-chosen behavior guidance techniques. Behavior Guidance Workgroup chose to collaborate on a survey with the Department of Oral Health Sciences at the University of Washington School of Dentistry on social/behavioral interventions for dental/orofacial pain. Survey results plan to be published in June/July 2022.




Additionally there were HRSA Recipient's Round tables for both pre- and post-docs following the main program.

📤 Legislative, Regulatory and Legal Update

Pediatric Oral Health Advocacy Conference in Washington, D.C., Promotes Key Legislative and Regulatory Issues

On March 14-15, 2022, over 250 AAPD members from 35 states plus D.C., advocated for children's oral health in Washington, D.C., by visiting with their members of Congress. AAPD attendees included members of the Council on Government Affairs, PAC Steering Committee, and Executive Committee. Twenty-six AAPD state Public Policy Advocates participated as well.

Forty-six pediatric dentistry residency program sites were represented, with over 160 residents in attendance. In addition to a briefing session the prior day (March 13), the AAPD also held advocacy orientation and training session solely for residents. An AAPD PAC appreciation reception was held on Monday evening March 14, to raise money for the PAC.

The specific advocacy requests made by attendees during Capitol Hill visits were:

HRSA TITLE VII PEDIATRIC DENTISTRY APPROPRIATIONS AND DFLRP TAX

Provide FY 2023 funding of \$46 million for the HRSA Title VII **Primary Care Dental Training** Cluster and related oral health programs, with not less than \$14 million for Pediatric Dentistry Training programs including continuation of a preference for pediatric dental faculty in the **Dental Faculty Loan Repayment** Program (DFLRP).

On April 27, 2022, a Congressional Dear Colleague Letter signed by 33 House members in support of FY 2023 funding for Title VII pediatric dentistry was sent to the Chair and Ranking Member of the House Appropriations Subcommittee on Labor, Health and Human Services, Education and Related Agencies. For the sixth straight year, this effort was led by Congresswoman Julia Brownley (D-Calif. 26th).

Pass legislation to make DFL-RP non-taxable to recipients. Co-sponsor S. 449/H.R. 1285.

ENSURING LASTING SMILES ACT

Support passage of the Ensuring Lasting Smiles Act (S. 754/H.R. 1916) legislation that would require all private group and individual health plans to cover the full medically necessary treatment of patients with congenital anomalies, including related dental procedures.

ELSA is supported by a coalition of 62 dental and medical provider and patient advocacy organizations.

On April 4, 2022, ELSA was approved by the U.S. House of Representatives on the suspension calendar by a 2/3 vote. The bill now moves on to Senate consideration. Thanks to strong bi-partisan support, the Senate bill currently has 40 co-sponsors.

ACCESS TO OPERATING ROOMS FOR PEDIATRIC DENTISTS

Contact the Centers for Medicare and Medicaid Services (CMS) and ask that the agency move forward this year to address severe oral health disparities affecting certain children and adults, particularly the disabled and those with special health care needs. CMS needs to do two things: set up a new billing code for use by hospitals to improve access to covered dental rehabilitative services and propose in the CY 2024 Hospital Outpatient Proposed Rule (HOPPS) rule that ambulatory surgery centers also be permitted to bill for dental rehabilitative services.

Congress Writes CMS In Support of Improved Dental Operating Room Access

The AAPD secured a bi-partisan Congressional Dear Colleague Letter (DCL) that was sent to the Administrator of the Centers for Medicare and Medicaid Services (CMS) in support of our efforts to obtain a HCPCS facility fee code for dental cases. This was due to Congressional visits that AAPD members made on March 14-15, 2022, as part of the Pediatric Oral Health Advocacy Conference. The DCL was led by Congresswoman Terri Sewell (D-Ala.7th) and Congressman/dentist Drew Ferguson (R-Ga.3rd). The AAPD applauds their leadership on this critical issue. The final letter included 25 House members and was sent to CMS on May 18, 2022. 
