

HIGHLIGHTS OF ACTIONS TAKEN BY THE AAPD BOARD OF TRUSTEES

- To add the name of Dr. Suzi Seale Coll to the list of Editors Emeritus in the journal masthead.
- To rename the Evidence Based Dentistry Service Award in honor of Dr. Suzi Seale Coll for her many contributions to the science of pediatric dentistry.
- To approve the recommendations of the Policy and Procedure committee to amend the AAPD Administration Policy
 and Procedure Manual in Section 8.P.20 to change the name of the New Pediatric Dentist Committee to The Committee on Early Career Pediatric Dentists.
- To direct the Safety Committee to move forward with development of a Safety Symposium for Fall 2019.
- To submit a letter in support of the National Council on Disabilities recommendation to the Commission on Dental Accreditation to revise standards to include competency in treating persons with special health care needs.
- To submit a letter in support of the National Council on Disabilities recommendation to the ADA to revise Principles of Ethics & Code of Professional Responsibility ("the ADA Code") to better promote treatment of persons with disabilities.
- To submit a letter to CODA asking to address the issue of removing the term "Specialty" from training standards documents.
- To approve convening a joint symposium in 2020 with the Royal College of Surgeons of Edinburgh.
- To approve Martha Wells and Kurt Swauger as co-chairs for the 2020 Local Arrangements Committee. (Annual Session location is Nashville, Tenn.)


We thank AAPD members those busy delivering PAC checks for the Congressional mid-term elections.

CONGRESSIONAL DEAR COLLEAGUE LETTER IN SUPPORT OF TITLE VII PEDIATRIC DENTISTRY FUNDING

As described in the May 2018 *PDT*, one of the key advocacy requests made by attendees at the 2018 AAPD Public Policy Advocacy Conference during their visits to Congressional offices was to support FY 2019 funding of **\$12 million** for Title VII Pediatric Dentistry. This amount includes funding for the Dental Faculty Loan Repayment Program. As part of this effort, attendees urged House Members to sign onto a *Dear Colleague* letter circulated by Congresswoman Julia Brownley (D-Calif.-26th) and Congressman Gregg Harper (R-Miss.-3rd). A copy of the final letter, signed by 38 House members, is provided below:

Dear Chairman Cole and Ranking Member DeLauro:

As you work to develop the Fiscal Year (FY) 2019 Labor, Health and Human Services, and Education appropriations bill, we ask for your continued support for programs crucial to addressing the unmet oral health needs of America's children. Dental decay is the most common chronic childhood disease in the United States, even though it is easily preventable. In addition, children from low income families have three to five times the level of untreated dental disease compared to their more affluent peers. Children with chronic dental pain face difficulty in school and in their everyday lives, negatively impacting their development for years to come.

Pediatric dentists are crucial to meeting the nation's health workforce needs. We urge the Subcommittee to include funding for Health Resources and Services Administration (HRSA) Title VII pediatric dentistry training at no less than \$12 million, including support for HRSA to continue funding grant opportunities for dental faculty loan repayment consistent with FY 2017 award criteria. We also urge continued robust funding for the overall primary care dental cluster (Section 748) and related dental programs.

This modest investment helps ensure highly-trained pediatric dentists can treat underserved populations and practice in underserved areas, thereby helping to stem the tide of early childhood dental disease. We thank the Committee for supporting this funding in the past, and request continued support in FY 2019.

CMS RELEASES GUIDANCE FOR PEDIAT-RIC DENTAL PERIODICITY SCHEDULES

On May 4, 2018, the Centers for Medicare and Medicaid Services (CMS) released an informational bulletin that discussed the importance of state Medicaid and Children's Health Insurance Programs properly implementing their pediatric dental periodicity schedules in order to ensure children's access to critical dental coverage. In its guidance, CMS said, "The fee schedule and payment policies in the state must align with the periodicity schedule regarding both age and frequency to ensure providers are able to be reimbursed for recommended care." CMS also stated that: "the periodicity schedule should be treated as a "floor" for coverage of dental services, not a "ceiling.""

STATE NEWS

WASHINGTON STATE EXPANDS ABCD PROGRAM

State Public Policy Advocate Dr. John Gibbons reports that earlier this year Washington state approved legislation to expand its well-regarded Access to Baby and Child Dentistry (ABCD) program. The ABCD expansion includes children with disabilities as eligible clients, and also allows dental hygienists to receive the enhanced reimbursements under the program. Gibbons worked on the bill with the support of state Senator Christine Rolfes (D). After being unanimously passed by the House and Senate, the bill was signed into law by Governor Jay Inslee (D) as shown below (Gibbons is standing to the governor's immediate right).



Request for Board of Trustees Nominations

Northeastern and NorthCentral Districts

The AAPD is accepting nominations for the trustee positions in two districts. Current Trustees Deven V. Shroff (Northeastern District) and Jessica A. Meeske (North-Central District) will rotate off the Academy's board of trustees at the conclusion of the 2019 annual session. Nominations for new trustees from the Northeastern and North-Central Districts, for a three year term of service beginning in 2019 and concluding in 2022, are now being accepted. Nominations must be transmitted to AAPD head-quarters from the Northeaster and NorthCentral District for their respective positions.

The nominations packet must be postmarked no later than Sept. 1, 2018, and returned to the AAPD headquarters office to the attention of Margaret Bjerklie. Nominations can be transmitted in one of two manners:

- Individuals from the Northeastern and NorthCentral districts can submit a nomination by including:
 - A letter signed by ten AAPD voting (Active or Life) members from the district signifying support of the nomination.
 - An AAPD nomination form* signed and dated by the Nominee
- 2. An AAPD state chapter in the Northeastern or NorthCentral district can submit a nomination by including:
 - A letter, signed and dated, from the president of the recognized state chapter certifying that the nomination is an official action of the state chapter.
 - The AAPD nomination form*, signed and dated by the Nominee.

Under either scenario, all materials must be forwarded to the respective district organization (Northeastern Society of Pediatric Dentistry or NorthCentral Society of Pediatric Dentistry) which will in turn forward these materials to the AAPD headquarters.

If two or more candidates are nominated, the AAPD will conduct an electronic ballot of each AAPD voting member in the respective district in order to select the trustee.

Resident's Corner

Celebrating Dr. Seale

A truly remarkable mentor is hard to find and someone you never forget. In residency especially, mentors are fundamental in shaping what type of practitioners we will become. They encourage, support and challenge us. With her recent passing, we want to acknowledge and celebrate one of the greatest influences of our profession, Dr. Suzi Seale. Seale was committed to teaching and mentoring since her graduation from Baylor's Pediatric Dental Residency in 1972 up until her retirement in 2017. She was appointed as the Chair of the Department of Pediatric Dentistry at Baylor, becoming the first woman to head a major dental school department in the country. Her leadership extended into organized dentistry on a local and national level, in addition to her research and passion for pulp therapy. With the intent to celebrate Seale's career, we sent out a questionnaire to many of her former residents to see what they had to say about her impact and the legacy she is leaving behind. AAPD Resident Recognition Awards

The AAPD Pediatric Dental Resident Committee developed the **Resident Recognition Award** to recognize pediatric dental residents doing innovative and interesting activities in their training programs. Selected residents are awarded with a monetary prize, featured on the AAPD website, featured in *Pediatric Dentistry Today (PDT)*, and recognized at the awards ceremony during the annual AAPD meeting.

Winners are chosen based on activities during residency that contribute to one or more of the following fields: patient care, education (i.e., teaching), research, and community service. Innovation, time commitment, and significance of service to others are the primary factors considered in the selection process.



Dr. Sara Ehsani

The University of Connecticut

Since dental school, Dr. Sara Ehsani has distinguished herself through a significant and ongoing education commitment. Her teaching experience included tutoring pre-dental students on dental procedures. Additionally, she was

Lab Teaching Assistant for ASDA, which included tutoring in Sim Lab on endodontic and restorative procedures. In her residency, she played a leadership role in developing new opportunities for dental students. Although part of this effort was a component of her Chief Resident administrative and teaching role, she initiated those activities early in her residency and continued them throughout her training. Through weekly clinical sessions, she aimed to improve students' pediatric rotation experience. She presented new ideas, assignments and treatment cases to prepare students for treating patients with special needs and complex medical histories. Also, with the encouragement from her program director, she has shown exemplary initiative by designing a 170-page clinic handbook, outlining guidelines and policies for the incoming residents. The handbook consists of contact information, clinical exam and treatment planning steps, administration of antibiotics, drug prescriptions, sedation preparation, orthodontic evaluation, assessment of trauma and on-call policies and procedures.

From the first year of residency she started collaborating with representatives of educational oral health services, esthetic crown companies and insurance agents. Through these channels, she helped establish seminars for her co-residents on pre-veneered and zirconia crowns, optimal oral hygiene habits, practice management, disability and professional liability insurance, and financial planning. Additionally, she was the recipient of the 2018 NuSmile Summit Scholarship, which provided her with unique learning opportunities.

Through research, she has developed the appetite for promoting healthy dental habits and targeting disparities in caries incidence. One of her greatest accomplishments is publishing 11 articles in various topics, including laser, pediatrics, implants, dental materials, and radiology. She was the primary investigator in five of her publications. She presented her research, in oral and poster formats, at 14 dental conferences. In residency, her research has focused on oral health

literacy. The data has been finalized and accepted for presentation in My Kid's Dentist Research Poster Competition and Graduate Student Research Award at AAPD 2018 in Hawaii.

Furthermore, she has volunteered in outreach activities, educational lecture series, and innovative hands-on demonstrations. In dental school, she organized "Give Kids a Smile Day", Saturday health-fairs and sealant trips to underserved areas. In residency, she continued her commitment to raise oral health awareness by collaborating with Child Health and Family Resource Clinic at Connecticut Children's Medical Center (CCMC) to help families find a dental home. Through establishing those health-fairs she was able to bring smiles to hundreds of underprivileged families and those with special needs. The health-fairs have been a huge success and continue every month. In addition, she has taken the initiative to expand her knowledge and experience by attending educational dental meetings, including Connecticut Society of Pediatric Dentistry and CCMC meetings, Texas Dental Association 2017 meeting, AAPD Sedation and Comprehensive Review courses. Recently, she attended the Connecticut Oral Health Initiative's Annual Advocacy Conference to become more involved in advocating for oral health and access to care issues in children, adolescents and patients with special needs. These experiences have strengthened her passion to promote oral health knowledge.



Dr. Brianna Muñoz

The University of Connecticut Community and Public Service

Dr. Brianna Muñoz is the first combined certificate/MPH resident at the University of Connecticut, and she has set the bar incredibly high. Muñoz will not only graduate with her MPH, but

also with a Certificate of Interdisciplinary Disability Studies in Public Health. She chose this extra certificate to further explore the multidimensional nature of public health as it relates to health care, society, culture, politics, economics, history, legislation, education, and social attitudes affecting persons with disabilities. Her goal is to impact policy in oral health for all children irrespective of race, ethnicity, income, or health status.

In pursing this aim, Muñoz is a board member for the Connecticut Society of Pediatric Dentistry as well as a representative on the Connecticut State Dental Association Legislative Council. This requires her to attend all board and legislative meetings. She serves our profession very well, and her desire to advocate for children is genuine. In the future, Muñoz will be a leader in this field as she is truly passionate and committed to continuing her work post-graduation.

Muñoz has instructed clinical lab exercises within the undergraduate curriculum, consistently scored high marks on her evaluations, and delivered seminar presentations that have been engaging and well researched. In light of this, she was selected to deliver a keynote seminar at the Annual Meeting of the Connecticut Society of Dental Assistants. In addition, Muñoz has created an Emergency Room protocol to address and correct certain deficiencies that had been noted. This has significantly improved management of after hour emergencies.

There is no doubt that Muñoz is an excellent provider and always takes any assigned responsibility to the next level. She has continuously created connections with other hospital departments to facilitate multidisciplinary relationships. She has spent a significant amount of time coordinating with ENT to routinely schedule tonsillectomies in conjunction with oral rehabilitation surgeries. This accomplishment minimized the overall exposure of general anesthesia to countless children. It has been a significant undertaking to identify patients in need of other surgeries and to collaborate with various hospital departments. Balancing this task in addition to her other duties has been an admirable feat.



Dr. Gail Silveira

The University of Tennessee

Dr. Gail Silveira has been exemplary in her efforts at mentoring pre-doctoral dental students. Dental Education has entered an era of declining numbers of pediatric patients needing restorative treatment. It has necessitated finding

creative ways to provide clinical experience for our students. Silveira has engaged pre-doc students almost daily, inviting those who have patients who fail their appointments to join her in the graduate clinic. She redeems the broken appointment, making it a teaching time. She allows the student doctor to treat her patients under her direct supervision. These efforts are self-generated and aimed at enriching the student's clinical experience. She has participated in almost every clinical outreach program the University of Tennessee has sponsored. At these you never find her treating patients alone. She always has students at her elbow. The motivation for this recommendation is my observation of self-sacrificing actions aimed at the dental student's enrichment.

Silveira has a complete grasp of clinical dentistry and is a very competent clinician. She completed a GPR and worked in private practice, so she has a wealth of experience to share with the students. She is extremely knowledgeable of all phases of pediatric dentistry. Her knowledge of dental literature is outstanding. She has excellent behavior management skills and is well liked by the children and parents. She is happy to teach this to students.

Silveira genuinely has a passion for dentistry, providing excellent care, and sharing her knowledge with others. She is willing to do whatever she needs to do to teach and show the students so that they can learn. This one-on-one attention is a unique service that we are able to provide our students, only because of her willingness to give, and when she graduates in June, the loss will be felt.

2018 – 2019 Samuel D. Harris Fellowship Recipient

Brianna Muñoz, D.M.D., was awarded the 2018-2019 Samuel D. Harris Research and Policy Fellowship sponsored by Preventech at the AAPD General Assembly on May 27, 2018. As this year's Harris Fellow, Muñoz will work with the Pediatric Oral Health Research and Policy Center on a research project focusing on the prevalence of dental sedation among pediatric patients aged 0-3 in a university setting with the objective of shedding light upon the decision making process and expounding upon risk factors.



Muñoz is currently a fellow at the University of Connecticut, where she completed dental school and a residency in pediatric dentistry. As the first postgraduate student accepted into the UConn-HRSA Dual Degree Training Program with Advanced Standing, she will be graduating this upcoming May with her M.P.H. degree as well as a Certificate of Interdisciplinary Disability Studies.

Her interest in public health was first incited while volunteering on a service trip to Neltume, Chile, where she was exposed to the plight of oral health care disparities. Since then, it has become her personal and professional goal to impact policy in promoting oral health and preventing disease for all children irrespective of race, ethnicity, or income level. In advancing this aim, Muñoz has participated in the AAPD Public Policy Advocacy Conference on Capitol Hill and served as a Connecticut Society of Pediatric Dentistry Board Member and Representative at the Connecticut State Dental Association Council on Legislation.

New AAPD Survey Tells How Pediatric Dental Practices Are Doing

The 2016 AAPD Survey of Dental Practice is now available online for AAPD members. It offers the latest information on central aspects of pediatric dental practices, as well as an inside look at such topics as perceptions of busyness, geographic variations in the pediatric dental workforce, Medicaid participation, and charitable care.

For example, did you know that 8 minutes is the national average for patient wait times to see the pediatric dentist upon arrival to the office? Or that the percentage of publically insured patients in a typical practice has increased from one-quarter to one-third in the last five years? New Research Available

Caries Predictive Model for Primary Care Providers Targets Children at Greatest Risk

A full report of the third year of research exploring oral health promotion in primary care is available on the AAPD website in the Policy Center. The model characterizes the likelihood a child would have oral disease or risks of future disease at the time of their first dental visit and is based



upon information noted in the early well-child visits.

Dr. John Timothy Wright was unanimously elected the chair of the Evidence-Based Dentistry (EBD) Committee. The board of trustees appointed Dr. James Coll as a consultant to the Committee, and Dr. Anupama R. Tate stepped down as chair due to her board responsibilities. The committee members are currently working on a mission statement, vision and goals.

The non-vital primary tooth pulp therapy systematic review workgroup, comprised of Drs. James Coll (chair), Kaaren Vargas, Shahad Al Shamali, Chia-Yu Chen, and Abdullah Marghalani, met in Hawaii for a full-day work session at the 2018 Annual Session. They developed the protocol for registration and data extraction sheets for both in vivo and in vitro. Data extraction and draft meta-analysis is expected to be completed by Nov. 30, 2018.

The EBD Committee has formed a new workgroup on behavior guidance for the pediatric dental patient. Members are Drs. Vineet Dhar, Elizabeth Gosnell, Cameron Randall and Rebecca Slayton. The committee nominated Dr. Dhar as the chair of the work group. The group will assess the quality of the existing systematic reviews.

Behind the Code

ICD-10-CM New Diagnosis Codes on the Horizon

Diagnosis codes, also referred to as ICD codes, are used to document the reason for a patient's visit or treatment. These codes are always required when submitting medical claims. Historically, dental payers have not required diagnosis codes for the adjudication of dental claims. Changes to our health care system have resulted in a growing trend of requiring diagnosis codes in addition to procedure codes.

Some of these changes include:

- Dental payers may require surgical extractions be filed with the patient's medical payer before submission to the dental payer.
- Pediatric dental benefits may be embedded in the medical plan, which is especially true for Affordable Care Act (ACA) plans.
- Medicare Advantage plans often have basic dental benefits embedded in the medical plan.
- Medical payers are increasingly providing benefits for some medically-related dental procedures.
- Some state Medicaid and ACA plans now require diagnoses codes for the adjudication of dental claims.
- There is an increasing trend toward dental payers requiring diagnoses codes on dental claims.
- Some prescription plans require a diagnosis code to fill a prescription.

When reporting diagnosis codes, it is critical that the most specific current code is reported. ICD-10-CM is the current diagnosis code set. Each year, ICD is reviewed and revised, like dental (CDT) and medical (CPT) codes. Unlike other code sets, which are effective for a calendar year (Jan. 1, to Dec. 31), ICD codes are effective for a fiscal year of Oct. 1, to Sept. 30, of each year. Therefore, the 2018 fiscal year (FY) ICD-10 code changes are effective starting Oct. 1, 2017.

In June 2017, Centers for Medicaid and Medicare Services (CMS) released the ICD-10 code update for FY 2018. The complete update is available for download (free of charge) at https://www.cms.gov/Medicare/Coding/IC018-ICD-10-CM-and-GEMs.html.

Because the implementation of ICD-10 was delayed for several years and revisions to the previous code set were halted, there were approximately 2,700 additions, deletions and revisions to FY 2017 ICD-10. This year, there are significantly fewer changes. FY 2018 ICD-10 features 363 new codes, 142 deletions and more than 250 code revisions.

CODES FOR DENTAL CARIES RISK FACTORS

Previously, there were no diagnosis codes available to report specific oral health risk factors. However, the FY 2018 ICD-10-CM code set includes a new category for oral health risk factors. In this category are classifications for dental caries risk factors.

The new codes are:

- Z91.8 Other specified personal risk factors, not elsewhere classified
- Z91.84 Oral health risk factors
- Z91.841 Risk for dental caries, low
- Z91.842 Risk for dental caries, moderate
- Z91.843 Risk for dental caries, high
- Z91.849 Unspecified risk for dental caries

At this time, CMS has not issued specific guidelines for these codes. There are, however, general guidelines for reporting "Z" codes. These codes are found in chapter 21 of the ICD-10-CM listing, entitled "Factors Influencing Health Status and Contact with Health Services." The chapter guidelines for reporting "Z" codes state, in part, "Z codes are for use in any healthcare setting. Z codes may be used as either a first-listed or secondary code, depending on the circumstances of the encounter." For example, an oral evaluation primarily for the purpose of determining the risk for dental caries would be reported with the appropriate risk code as the primary diagnosis.

Sometimes, an oral health risk factor is the result of a primary disease process. For example, Sjogren's syndrome increases the risk of tooth decay and oral infections. If the primary reason for the visit is treatment due to symptoms related to Sjogren's, the ICD-10-CM code reporting the condition is listed as primary, and caries risk is listed second. It is important to note the level of risk in the clinical notes.

The codes below would be reported for a patient documented with a diagnosis of Sjogren's and a high risk of dental caries:

- M35.00 Sicca syndrome, unspecified
- Z91.843 Risk for dental caries, high

REVISIONS TO WORDING OF NICOTINE DEPENDENCE

Some revisions are not to the code itself, rather additional information has been added to guide the provider in the use of a code. One example of this is found in category F17 (nicotine dependence). This category is further divided based on the type of tobacco product (i.e., cigarettes, chewing tobacco, or other tobacco product). ICD-10-CM for FY 2018 now has additional clarification on the application of these codes.

When reporting codes F17.201-F17.291 the following conditions apply:

Keep in mind, only diagnosed conditions that are documented in the clinical record may be reported. It is important that the patient's condition is accurately noted in the medical record. Furthermore, reporting diagnoses codes does not guarantee reimbursement by *either medical* or dental payers. Always report the most specific ICD-10-CM code available to accurately describe the patient's condition or the disease process treated.

The Symposium provides an excellent opportunity to network with federal and state-level Medicaid administrators and provide visibility to AAPD policies and resources on access to care for low-income children.

This year, the Symposium theme was "Demonstrating Value in Medicaid Dental Programs." Considerable attention has been given to value-based healthcare systems in the U.S. over this past year, with funding being the primary focal point. This Symposium featured how to create, administer and deliver an efficient and cost-effective Medicaid dental benefit. It covered everything from legislative framing benefits, the creation and administration of a value-based benefit, the application of policy levers to the use of evidence-based practices that include appropriate metrics.

Dr. Jessica Meeske was one of four speakers on the *Increasing Efficiency in Service Delivery* panel. Meeske presented a well-received discussion on providing value to her patients and Medicaid programs, identifying the value that Medicaid brings to her practice, as well as why she sees Medicaid patients and how dentists will react to a value-based system. Dr. Scott Schwartz, Cincinnati Children's Hospital Medical Center

Immediately after deciding to become a dentist as a sophomore in high school, I routinely pictured my life as a private practitioner in a leafy Chicago suburb. During dental school, however, I realized the extent to which educational institutions are responsible for shouldering the significant amount of dental disease that persists among the poor and minority groups. As a result, my career goals veered away from a traditional clinical career in private practice. Instead, I developed an interest in public health and academic dentistry, a curiosity I fed through my specialty training in pediatric dentistry and formalized with a masters degree in public health. After studying health policy and management, reconciling my own feelings towards a for-profit health care model, and gaining significant exposure to the joys of teaching, I was compelled to explore academics as a full-time career. When I finally started my dream job at Cincinnati Children's Hospital Medical Center and the dust settled from 26 years in school, I fully understood the financial implications of professional school student loans. Academic pediatric dentists make significantly less than their private practice counterparts, which can make long-term dedication to this career difficult. Just my monthly student loan obligation would consume more than half of my salary before accounting for other necessities. Dental faculty loan repayment through the Health Resource and Service Administration will facilitate paying down the debt burden to a point where the income differential will no longer affect my commitment to a career dedicated to education and public service. It is a truly life changing gift to more completely embrace my decision to pursue a career in academic dentistry, influencing the practice of our future pediatric oral health practitioners.



Are Your Investments Appropriate for Your Retirement Goals?

Aligning risks and returns to the needs of your financial plan

"Are my investments appropriate for my retirement goals?" This is a question we hear frequently. Obviously, the answer is different for every person. Here is how we go about determining our response.

Before you even look at investments, consider your retirement goals.

In our practice, before we even address the issue of investments, we will do a thorough analysis of a client's financial picture in retirement. Questions we ask include:

- When would you ideally like to retire?
- What kind of lifestyle would you like to have?
- Will you work still, a little, or not at all?
- What active and passive income sources might you have?

Investment returns should fill the gap between your future income and future spending. So before you decide how to structure your investments, let's look at your cash flow in retirement.

Let's take a look at your spending in retirement.

While retirement may be twenty or thirty years out from now, looking at today's spending patterns actually provides huge clues as to what future spending might look like.

Some expenses that people may be currently running through their dental practice may become personal expenses in the future. These include car expenses, and some types of insurance. Some current expenses may not exist at all in retirement. Frequently this will include mortgages, debt, and the need to continue saving.

Other, new expenses may take their place! Extended medical care, or other household support is expensive. There may be more travel in the picture, spoiling the grandchildren, new hobbies, and other things people do when they have more time and freedom.

Now let's take a look at your income in retirement.

What income sources will continue for you in retirement? This may include Social Security payments, a pension perhaps if you worked as faculty or in a hospital that offered such a program, or rental income from properties you own. If you decide to scale back at work over time, we'll factor in your (reduced) income into the equation.

If you have assets from the sale of a practice, those, too, will be taken into consideration.

The difference between your incoming cash flows, and your projected expenses needs to be filled by your investment portfolio.

Now let's see if your investments are appropriate for your goals.

The first thing that we need to do is understand a person's risk tolerance for investing. We do this by determining their 'risk score.' A simple questionnaire, and the use of specialized financial planning software gives us insight into an individual's tolerance for fluctuations in the market.

The reason that risk tolerance is so important is because we want to make sure that the investment program we recommend is within an individual's range of expectations – for both risk and, commensurately, returns.

We know the markets will go up, and we know the markets will go down. An educated investor knows that if the value of his/her holdings goes down in a particular month or quarter, this is to be expected. Alternately, if a portfolio is doing exceedingly well — beyond expectations — the person won't get carried away and decide to invest exclusively in those assets that are top performers at this moment in time. The point is to stay the course for the long term, and make suitable adjustments along the way.

We always discuss with our clients, in advance, how they might behave in a bull market (when markets are up), what they anticipate they might do in a bear market (when markets are down), and what could potentially happen in a financial crisis. Thinking through these scenarios helps mitigate what might be a purely emotional response through some rational thinking.

Sometimes, the return that your portfolio needs to produce in retirement is greater than what your risk tolerance will allow. At this point we have a conversation with the client. The choices are to either increase savings, or to slightly ratchet up one's tolerance for risk. For most people, frequently, it's a combination of both.


