Report of the American Board of Pediatric Dentistry

The transition to our ABPD Headquarters in Iowa City is complete. Executive Director Art Nowak and Executive Assistant Linda Sojka are providing ABPD candidates, Diplomates, and the Board of Directors outstanding service in an efficient, effective and user-friendly manner. Our website at www.abpd.org is in full operation with complete documentation of our application forms, examination procedures, and grading protocols such that essentially all activity can be done on-line. The site also provides links to the AAPD, the College of Diplomates, and the AAP. As of March 19, 2003 the ABPD Headquarters has been able to process examination charges, annual fees, via MasterCard or Visa and the process has already been well received by our constituents.

The financial status of the Board remains stable with documentation of auditing procedures and outcomes will be provided to the AAPD Executive Committee under separate cover from our Executive Director.
