
AAPD Membership Demographics









AAPD AFFILIATE MEMBERS BY GENDER

AAPD® Finances Remain Strong

Martin and Martin conducted the audit of the AAPD's financial statements for the year ending June 30, 2017. AAPD experienced a gain during the year of \$300,088, reflecting total revenues of \$11,799,206 compared to expenses of \$11,499,118. The financial highlights for the current fiscal year as of February 2018 are as follows:


- AAPD core operations have generated a net gain of \$491,517. The
 budgeted net loss for the year ending June 30, 2018, is \$785,620, but we
 are running well ahead of this and expect to close the year with a net gain
 similar to last year's.
- Investment reserves as of Feb. 28, 2018, were \$7,507,101.
- Total assets as of Feb. 28, 2018, were \$12,140,410.

Dental Insurance and Dental Coding Assistance

The AAPD provides members with hands-on assistance related to third-party reimbursement (dental and medical insurance) and coding. Our goal is to answer your questions regarding dental and medical coding, effective utilization of dental benefits and provide technical assistance to help resolve any difficulties that your practice may be having with claims submitted to dental or medical plans. Calls come in regularly from members seeking assistance with appealing denied claims, determining appropriate coding, utilizing general anesthesia legislation requirements, coordination of benefits, conversion of dental to medical and diagnostic codes, the Affordable Care Act as it relates to pediatric oral health benefits, and various other third party reimbursement issues. Below is a summary of the insurance or coding matter and number of member calls received in the period from January 2017 to January 2018. All inquiries have been successfully resolved for AAPD members.

Coding and Insurance Manual

An electronic update of the AAPD Coding and Insurance Manual (2018) was offered to members free of charge due to the generous support from Avesis Dental, Delta Dental of California and MCNA Dental. These corporate partners previously covered all printing and mailing costs for the 2017 manual. The 2018 update includes dental procedure codes, medical procedure codes and diagnostic codes used routinely by pediatric dentists. It also offers recommendations for submitting dental and medical claims, the appeal process for denied dental claims, contacts for all state insurance commissioners, carrier-friendly narratives for common procedures and a glossary of pediatric dental terms, and other sources of pertinent information useful to the dental team.

Ongoing Coding and Insurance Resources

The dental benefits and coding webpage on AAPD's website continues to be updated with new and pertinent information. In addition, timely insurance and coding information is regularly included in AAPD E-News, with recent items concerning legislation regarding non-covered services, general anesthesia, and the Affordable Care Act. Code on Dental Procedures and Nomenclature (CDT Code) Update and AAPD Initiatives

The ADA's Code Maintenance Committee (CMC) ensures that all stakeholders have an active role in evaluating and voting on CDT Code changes. The CMC is a 21-member voting body that votes to accept, amend or decline requests. All requests where the decision is appealed by the submitter are returned to the CMC for further consideration. The CMC is expected to arrive at decisions that are in the best interests of the profession and patients, and third-party payers/administrators. Dental codes are revised on an annual basis, and the AAPD is proactively engaged in the CMC process.

Notable CDT 2018 additions and revisions that pertain to pediatric dentists are as follows:

NEW CDT 2018 CODES

- D0411 HbA1c in-office point of service testing
- D8695 removal of fixed orthodontic appliance(s) for reasons other than completion of treatment

Rationale: This procedure is not associated with the removal of fixed appliances and the placement of fixed or removable orthodontic retainers at the completion of treatment (D8680). This includes the removal of appliances by another dentist when the patient has left the practice of the treating dentist. Example: remove brackets for wedding day or prior to MRI

D9222 deep sedation/general anesthesia – first 15 minutes

Anesthesia time begins when the doctor administering the anesthetic agent initiates the appropriate anesthesia and non-invasive monitoring protocol and remains in continuous attendance of the patient. Anesthesia services are considered completed when the patient may be safely left under the observation of trained personnel and the doctor may safely leave the room to attend to other patients or duties.

The level of anesthesia is determined by the anesthesia provider's documentation of the anesthetic effects upon the central nervous system and not dependent upon the route of administration. Rationale: Aligns with the medical model for the provision of anesthesia services.

D9239 intravenous moderate (conscious) sedation/analgesia – first 15 minutes

Anesthesia time begins when the doctor administering the anesthetic agent initiates the appropriate anesthesia and non-invasive monitoring protocol and remains in continuous attendance of the patient. Anesthesia services are considered completed when the patient may be safely left under the observation of trained personnel and the doctor may safely leave the room to attend to other patients or duties.

Rationale: Aligns with the medical model for the provision of anesthesia services.

D9995 teledentistry – synchronous; real-time encounter Reported in addition to other procedures (e.g., diagnostic) delivered to the patient on the date

Rationale: This administrative code documents the synchronous transmission of patient information to a remote site and allows not only documentation but also billing for the costs associated with such transmission.

D9996 teledentistry – asynchronous; information stored and forwarded to dentist for subsequent review

Reported in addition to other procedures (e.g., diagnostic) delivered to the patient on the date of service.

Rationale: This administrative code documents the asynchronous transmission of patient information stored and forwarded to a remote site and allows not only documentation but also billing for the costs associated with such transmission.

REVISED CDT 2018 CODES

D1354 interim caries arresting medicament application per tooth

Conservative treatment of an active, non-symptomatic carious lesion by topical application of a caries arresting or inhibiting medicament and without mechanical removal of sound tooth structure. Rationale: The current nomenclature lacks specificity as to the application of the caries arresting or inhibiting agent. It is unclear if the application should be coded and reimbursed as a per-surface, per tooth, per quadrant, per arch, or per mouth service. Unless procedure D1354 is interpreted and reported as a per tooth procedure, it is impossible to track individual tooth outcomes and follow-up procedures in the patient record. Some treated teeth will require reapplication at determined intervals, some will be followed to exfoliation, and others will eventually receive definitive restorative care as individual patient circumstances dictate.

Note that this revision to D1354 was submitted and advocated by the AAPD. This is especially important because this code should be used to report application of Silver Diamine Fluoride (SDF).

• D1555 removal of fixed space maintainer

Procedure performed by dentist or practice that did not originally place the appliance.

• D4355 full mouth debridement to enable a comprehensive evaluation and diagnosis on a subsequent visit

Full mouth debridement involves the preliminary removal of plaque and calculus that interferes with the ability of the dentist to perform a comprehensive oral evaluation. Not to be completed on same day as D0150, D0160, or D0180.

Rationale: Clarifies that subsequent visit is necessary for comprehensive evaluation.

D9223 deep sedation/general anesthesia – each subsequent 15 minute increment

Rationale: Aligns with the medical model for the provision of anesthesia services.

D9243 intravenous moderate (conscious) sedation/analgesia – each subsequent 15 minute increment

Rationale: Aligns with the medical model for the provision of anesthesia services.

CDT 2019

The CMC met on March 15, 2018, to determine which substantive and editorial action requests on the committee's agenda would be accepted or declined for CDT 2019. Official notice of the CMC's decisions will be posted in the "Action Report" at http://www. ada.org/3830. aspx. Accepted actions will be effective Jan. 1, 2019, in CDT 2019.

Regional and State Code Workshops

The AAPD continues to offer coding and insurance workshops to district and state chapters. The state or district is responsible for the speaker's airfare and lodging expenses. This member benefit is known to all state Public Policy Advocates and AAPD encourages state chapters to schedule such a workshop as part of the their state academy's annual meeting in 2018 or 2019. Recent workshops were presented at the Texas Academy of Pediatric Dentistry (January 2016) and the Indiana Academy of Pediatric Dentistry (April 2016).

According to the story:

"Sedation is above and beyond routine dentistry," so the first thing parents should ask is whether it's necessary, said Dr. Paul Casamassimo, the chief policy officer for the American Academy of Pediatric Dentistry's research center.

The quality of dentists' sedation training matters, because a dentist needs to be able to choose the right candidates and the appropriate drug and know how to rescue an over-sedated child. Pediatric dentists train for an added two or three years to learn sedation. By contrast, a general dentist may have taken a weekend course in moderate sedation. "Classroom training is not enough," Dr. Studen-Pavlovich said.

"The bottom line is parents should be told the risks, benefits and alternatives," Dr. MacLean said. "If not, get a second opinion."

addressing the issues surrounding sedation/general anesthesia in pediatric dentistry, current AAPD guidelines/recommendations, and as well as offering insight on how to discuss these issues with patient's parents and their families.



2017 Survey of Pediatric Dental Practice

The AAPD Survey of Dental Practice supplies up-to-date information on critical functions of pediatric dental practices, as well as offers an inside look at such topics as changing demographics of the profession, perceptions of busyness, geographic variations in the pediatric dental workforce, Medicaid participation, and charitable care. The survey was distributed to 6,505 selected AAPD members last summer, garnering a response rate of 39 percent (2,549 responses out of 6,505).

Intriguing findings from the survey include:

- Publically insured patients represent a higher percentage of pediatric dental practice patients in 2016 (34 percent) than in 2011 (26 percent).
- The majority of pediatric dentists in 2016 were women (52 percent) compared with only 14 percent in 1998.
- In 2016, 45 percent of pediatric dentists reported three or more dentists in their primary work setting compared to 11 percent in 2011.
- The percentage of pediatric dentists providing charitable care increased from 74 percent in 2011 to 78 percent in 2016.

Pediatric Dentist Workforce Study Analyzes Future Supply and Demand

Last year the AAPD contracted with the Center for Healthcare Workforce Studies (CHWS) at University at Albany-SUNY to conduct a pediatric dentist workforce study to provide the profession and policy-makers an overall target for the ideal number of pediatric dentists in the U.S. The study consisted of a comprehensive literature review and interviews, online survey to members, prediction equations for supply of and demand for pediatric dentists, and a health workforce simulation model to develop projections of future supply and demand for pediatric dentists. Basic findings can be summarized as follows:

- The overall number of pediatric dentists appears adequate, but there are geographic distribution issues.
- Due to recent increases in residency positions, the overall number of pediatric dentists will continue to grow slowly as projected to the Year 2030.
- There are scenarios where increased demand could require faster growth, such as pediatric dentists seeing a larger share of younger children as compared to general dentists and dentally insured children (in both public and private programs) utilizing dental services at a higher rate. This is especially significant because currently 90 percent of children in the U.S. have dental insurance coverage, the highest percentage ever.

Full results from the workforce study will be published in fall of 2018.

Final Report Now Available: Predictive Model for Caries Risk Based on Determinants of Health Available to Primary Care Providers

A full report of the third year of research exploring oral health promotion in primary care is now available through the AAPD Policy Center website at http://www.aapd.org/policy_center/.

With an aim of creating a history-based, caries-risk screening tool that more easily assimilates into the work flow of a well-child visit, a predictive model was developed at Nationwide Children's Hospital (NCH) in Columbus, Ohio. The model characterizes the likelihood a child would have oral disease or risks of future disease at the time of their first dental visit and is based upon information noted in the early well-child visits.

The study, with over 2,000 infants, produced a predictive model that suggests the odds of a child having tooth decay at the first dental visit more than doubles for every year of increased age for this visit. Additionally, it offers clues to assist health care professionals identify tooth decay risk in young children before even looking in their mouths. Starting at the 18-month well-child visit, health care providers can use five variables to assess the odds of future or present tooth decay risk. The five variables are:

- Age of the child
- History of a preventive dental health visit
- Duration of breastfeeding (past age 1)
- No-show rate (such as broken appointments, etc.)
- Preferred spoken language

With such a predictive tool, health care providers could easily administer caries-risk assessment as a part of the well-child visit without taking time from other equally important health concerns.

Harris Fellowship Update

Analyzing Pediatric Dental Access in Community Health Centers



Wayne Stephens, D.D.S., M.B.A., the 2017-2018 Samuel D. Harris Research and Policy Fellow, worked with the POHRPC and Drs. Amr Moursi and Vinod Miriyala on a research project focusing on the role and impact of pediatric dentists in federal qualified health centers. The survey was distributed by the National Network for Oral Health Access (NNOHA) in early 2018.

The findings will be presented at the Annual Session in Honolulu.

Harris Fellows Publish in Pediatric Dentistry Journal

Scott B. Schwartz, D.D.S., M.P.H., and Benjamin D. Curtis, D.D.S., recipients of the 2015-2016 Samuel D. Harris Fellowship, published original research articles in the September-October 2017 issue of *Pediatric Dentistry*.

In Schwartz's article, "Pediatric Dentists' Attitudes, Perceptions, and Experience With the Affordable Care Act," study respondents reported a lack of understanding of ACA benefits by parents and deferral of both preventive and restorative care due to high out-of-pocket costs. Additional authors of the article were Dr. Jessica Lee, Dr. Paul Casamassimo, Dr. Paul Reggiardo, Dr. Robin Wright and C. Scott Litch.

The article by Curtis, "Strengthening the AAPD Public Policy Advocate Network: Identifying Advocacy Efforts and Recommendations," collected information on the involvement, training, and barriers to participation in advocacy efforts for state Public Policy Advocates (PPAs). Co-authors included Dr. Ashley Orynich, Dr. Paul Casamassimo, Dr. N. Sue Seale, Dr. Paul Reggiardo, Dr. Robin Wright and C. Scott Litch.

New Technical Brief: Are Your Kids Covered? Medicaid Coverage for Essential Oral Health Benefits

This technical brief presents the findings of a POHRPC research project on state Medicaid coverage of selected dental procedure codes by Erica Caffrey, D.D.S., M.S., 2016-2017 Samuel D. Harris Fellow. It identifies the pediatric dental procedures most essential for coverage, catalogs the coverage of these procedures by state, and specifies problem areas of coverage for oral health services. Designed as a state-level advocacy resource, this publication will be of valuable assistance to members as they champion for



extended access to care through public insurance of oral health services for children. The brief was co-authored by Dr. Anupama Tate, Dr. Scott Cashion, Dr. Jessica Lee, Dr. Paul Casamassimo, Dr. Robin Wright, C. Scott Litch and Mary Essling.

New Technical Brief: Pediatric Dentist Toolkit for Seeing Patients with Medicaid: Changing Children's Lives One Smile at a Time



This toolkit is an invaluable guide to getting a Medicaid program started in a pediatric dental practice. It covers such practical concerns as how to become a dental Medicaid provider, schedule patients wisely, maintain compliance, and find training opportunities for team members. The publication features solid answers to common questions about participating in Medicaid, as well as an assortment of time-saving resources.

State of Little Teeth: Resurgence

The popular 2014 AAPD publication, State of Little Teeth, is being updated and revised to reflect scientific advances, oral health trends and legislative changes. While this second edition will continue to feature information on the epidemic of caries in young children and the impact of caries on quality of life, it will extend into such topics as dental disparities through childhood, workforce issues, and pediatric dentistry's commitment to the safety of child patients. Slated for publication in mid-2018, the second edition project team includes POHRPC staff, Advisory Board members, and UIC pediatric dental resident Dr. Brittaney Hill.

Conference Participation Builds AAPD Visibility

At the National Conference of State Legislators held Aug. 6-10, 2017, in Boston, Drs. David Tesini and Hubert Park provided key policy-related messages to legislators and legislative aides from nearly every state through the AAPD exhibit booth. The AAPD shares a prime exhibit booth location on the floor of the NCSL trade show with the ADA and the Academy of General Dentistry.

The AAPD hosted an exhibit booth at the Annual Conference of the National Network of Oral Health Access (NNOHA) in San Diego, Calif., on Nov. 12 - 16, 2017, and the National Oral Health Conference, April 15-18, 2018, in Louisville, Ky., sponsored by the Association of State and Territorial Dental Directors and American Association of Public Health Dentistry.

AAPD Speaks to Childhood Obesity and Sugared Drinks

"Calories, Cavities, and Kids: The Role of Dental Professionals in Addressing Childhood Obesity" was a topic of interest for NNOHA during a one-hour webinar presented by Dr. Robin Wright on Feb. 5, 2018. The continuing education session discussed how oral health professionals can join collaborative efforts with their colleagues to combat childhood obesity. New Course on Difficult Conversations Slated for AAPD 2019

The Policy Center is developing an interactive educational session on how to provide communication-based interventions on such difficult oral health-related topics as overweight/obesity, substance use, STDs, and transgender issues. The objective of the session is to boost communication skills and confidence in addressing topics that might make parents and adolescents feel embarrassed, judged negatively, or unlikely to return to the pediatric dental practice. The course has been approved by the Scientific Program Committee for the 2019 Pre-Conference Program at the AAPD Annual Session in Chicago.

Safety Committee Update

The AAPD Committee on Safety was created by the board of trustees to:

- Examine the processes and culture of patient safety as they pertain to the practice of pediatric dentistry.
- Make recommendations to the AAPD as to possible initiatives the organization could implement to enhance the safety of children in a pediatric dental office.

Its vision is the delivery of the safest possible oral health care, protecting the health and well-being of patients and their providers. Its mission is to apply the diverse resources of the AAPD in aiding dentists to create a culture of safety for both patients and providers in the dental setting, accomplished by building and incorporating systems of safety into all aspects of the delivery of oral health care. Members are Drs. Jade Miller, Chair, Paul Casamassimo, Charles Czerepak, John Liu, Paul Reggiardo and Leila Younger. Staff liaisons are Dr. John Rutkauskas and Policy Analyst Leola Royston.

The committee met in Chicago in December, 2017, and April, 2018. Members have completed a Delphi exercise in which various topics related to safety were reviewed and discussed (sedation, office policies and procedures, physical safety patients, physical safety staff, infection control, and therapeutics). They also assisted in clarifying a key issue of personnel support as discussed in the joint AAP/AAPD sedation guideline. Under development is a new "Safety Issues and Actions" web page to be located on the AAPD website under the "Public Policy and Advocacy" tab. Some of the potential deliverables the committee may produce are:

- "Safety Corner" article in each issue of Pediatric Dentistry Today (PDT).
- "Office Safety Elements" manual/toolkit.
- Safety Symposium in 2019.
- Review and update of existing AAPD sedation policies and recommendations to match the joint AAP/AAPD sedation guideline and addendum.
- Engage OSAP (The Organization for Safety, Asepsis and Prevention) about hosting another webinar (e.g., infection control).

Education Continues Through Smiles for Tomorrow

The POHRPC completed updates for Smiles for Tomorrow, an online self-instructional continuing education module hosted by Procter & Gamble. Topics reviewed in the course include normal oral structures, common oral conditions, eruption pattern, orofacial trauma, and dental caries and prevention. Upon completion of this course, users will better understand appropriate evaluation, treatment and preventive measures that should be instituted during infancy and continued on a regular basis to maintain optimal health.

Evidence-based Dentistry Committee Update

Two new EBD guidelines were accepted by the National Guideline Clearinghouse:

- Clinical Practice Guidelines for use of Vital Pulp Therapies in Primary Teeth with Deep Caries; and
- Clinical Practice Guideline on the Use of Silver Diamine Fluoride for Dental Caries Management in Children, Adolescents and Individuals with Special Healthcare Needs.

Patient education materials based on the new guidelines have been developed for silver diamine fluoride, pulpotomy and indirect pulp therapy. They are available through the AAPD's online bookstore.

The non-vital pulp systematic review workgroup, composed of Drs. Shahad Al Shamali, Chia-Yu Chen, James Coll, Abdullah Marghalani, N. Sue Seale and Kaaren Vargas, met in December to begin work and are meeting for a full-day work session at the 2018 Annual Session. In vivo and in vitro protocols will be registered within the year.

The EBD Committee is forming a new workgroup on behavior guidance for the pediatric dental patient. The new behavior guideline, based on an existing systematic review, will be published in early 2019. The table below summarizes the status of all AAPD EBD clinical practice guideline development to date.

Public Policy Advocacy for Children's Oral Health

The AAPD continues to vigorously advocate for critical issues impacting children's oral health care. The 2018 Legislative and Regulatory Priorities, as developed by the Council on Government Affairs and approved by the board of trustees, are available on the AAPD website at http://www.aapd.org/assets/1/7/2018_Legislative_Priorities_for_website.pdf.

In additional to our efforts at the federal level in Washington, D.C., our state Public Policy Advocates continue to make important strides on legislative and regulatory matters at the state level. Our success in D.C., is thanks in no small part to the work of Congressional Liaison Heber Simmons Jr., our lobbying consultants at Hogan Lovells, and of course the AAPD Political Action Committee.

Public Policy Advocacy Conference (PPAC) in Washington, D.C.











On March 5-7, 2018, nearly 300 AAPD members from 36 states plus D.C., advocated for children's oral health in Washington, D.C., by visiting with their members of Congress. AAPD attendees included members of the Council on Government Affairs, PAC Steering Committee, Executive Committee, and Budget and Finance Committee. Twenty-nine AAPD state Public Policy Advocates participated as well. Thirty-six pediatric dentistry residency programs were represented, with more than 175 residents in attendance. For the third year, the AAPD held a special pre-conference advocacy orientation and training session for residents.

Attendees heard updates on key AAPD public policy issues focusing on Title VII pediatric dentistry funding and student loan repayment reform legislation, as well as an update from the ADA on the Affordable Care Act, Medicaid, and CHIP. The keynote speaker was Michael Barone, currently senior political analyst for *The Washington Examiner*, Resident Fellow at the American Enterprise Institute, and contributor to Fox News. Barone discussed the current political landscape and the upcoming 2018 Congressional mid-term elections.

The AAPD PAC hosted a fundraiser for **Congressman Tom Cole** (**R-Okla.-4th**), chair of the House Appropriations Subcommittee on Labor, Health and Human Services, and Education. Cole is a fifth generation Oklahoman and an enrolled member of the Chickasaw Nation. He is one of only two tribal members currently serving in Congress. The event, co-sponsored with ADPAC, AAOMS PAC and Hogan Lovells PAC, raised over \$15,000.

The specific advocacy requests made by attendees during Capitol Hill visits were:

• Fund Title VII Pediatric Dentistry

Provide FY 2019 funding of \$40.673 million for the primary care dental Title VII program with \$12 million for Title VII Pediatric Dentistry that includes funding for the Dental Faculty Loan Repayment Program.

As part of this effort, attendees urged House Members to sign onto a Dear Colleague letter circulated by Congresswoman Julia Brownley

(D-Calif.-26th) and Congressman Gregg Harper (R-Miss.-3rd) that asked members to **support a bipartisan call for investment in pediatric dental care**. The final letter included 38 signatures and will be printed in the July 2018 *PDT*.

- Make dental faculty loan repayments non-taxable to recipient or allow institutions to offset tax liability.
 - The dental faculty loan repayment program would have even greater impact if made non-taxable to recipient or if institutions were allowed to use grant funds to offset tax liability.
- Support H.R. 372, repeal of antitrust exemption for health insurance companies.

H.R. 372, repeal of the McCarran-Ferguson Act, was approved by the House on March 22, 2017. A Senate bill has yet to be introduced

 Support H.R. 4001, student loan refinancing and restoration act.

H.R. 4001 would:

- » Allow borrowers to refinance their student loan interest rates to the 10-year Treasury note rate, plus one percent, throughout the lifetime of the loan.
- » Eliminate origination fees and instead set future student loan interest rates at the 10-year Treasury note rate, plus one percent.
- » Delay student loan interest rate accrual for many low- and middle-income borrowers while they are in school.
- » Allow for borrowers in medical or dental residencies to defer payments until the completion of their programs.

ACA Rolls On and AAPD Continues Advocacy for Children's Oral Health Provisions

Congressional efforts by the Republican Majority to repeal and replace the Affordable Care Act (ACA) were not successful in 2017.

On June 9, 2017, the AAPD joined the ADA and over 40 other national associations or organizations to highlight key priorities in 2017 health care reform legislation. Specifically, the letter emphasized the importance of the Medicaid guarantee of Early and Periodic Screening, Diagnostic and Treatment (EPSDT) for children's dental coverage, and retaining children's pediatric oral health care as an essential health benefit. On June 26, 2017, the AAPD joined a coalition of dental organizations writing to key Senate and House committee chairs and ranking members (Senators Orrin Hatch, R-Utah, Lamar Alexander, R-Tenn., Patty Murray, D-Wash., and Ron Wyden, D-Ore.) with a copy to the Senate Majority Leader (Mitch McConnell, R-Ky.) and Minority Leader (Chuck Schumer, D-N.Y.) asking that the pediatric oral health essential health benefit provision in the ACA be retained.

An ACA open enrollment period took place (albeit shorter than the prior year) and – while the final tax reform law did eliminate the ACA individual mandate penalty – for 2018 the ACA lives on. Note that starting in 2019 there will be premium tax assistance for purchase of stand-alone dental plans for those who purchase a qualified health plan that does not provide pediatric dental benefits.

CHIP Reguthorized for 10 Years

AAPD continued our advocacy for reauthorization of the Children's Health Insurance Program (CHIP) and actively engaged our state Public Policy Advocates (PPAs) and e-Advocates network in these efforts. On Sept. 30, 2017, Congress allowed CHIP to expire, potentially impacting nearly 9 million children's access to oral health care. On Nov. 29, 2017, we joined the ADA in calling for a Day of Action for CHIP Reauthorization, asking dentists to e-mail their Members of Congress via a link provided by ADA. Additionally, a joint AAPD-ADA letter from Presidents Nickman and Crowley was sent to key Congressional leaders on Dec. 14, 2017.

Although funding lapsed on Sept. 30, 2017, Congress acted on Jan. 22, 2018, to pass a six-year CHIP extension, and again on Feb. 9, 2018, to extend CHIP for an additional four years through FY 2027. During PPAC Congressional visits described above,

AAPD attendees thanked all Senators and Representatives for their support of CHIP reauthorization.

CHIP Background: CHIP was created in 1997 with strong bipartisan support to provide coverage for children who fell above Medicaid eligibility levels but lacked access to other options. CHIP was specifically designed to include child appropriate benefits, access to pediatric providers, and cost-sharing limits to protect children and families. States that provide CHIP coverage to children through a Medicaid expansion program are required to provide the EPSDT benefit, which includes dental coverage. Dental coverage in separate CHIP programs is required to include coverage for dental services "necessary to prevent disease and promote oral health, restore oral structures to health and function, and treat emergency conditions." States with a separate CHIP program may choose from two options for providing dental coverage: a package of dental benefits that meets the CHIP requirements, or a benchmark dental benefit package. The benchmark dental package must be substantially equal to: (1) the most popular federal employee dental plan for dependents; (2) the most popular plan selected for dependents in the state's employee dental plan; or (3) dental coverage offered through the most popular commercial insurer in the state. CHIP is one of the reasons that 90 percent of children in the U.S. currently have dental insurance coverage.

Section 1557 of ACA: Update

Section 1557 regulations required the following of dentists (and other health care providers) by October 16, 2016, if they receive federal financial assistance such as Medicaid or CHIP reimbursement:

- Posting a notice of non-discrimination in the office, on its website, and in significant publications and communications.
- Including taglines in the top 15 non-English languages spoken in
 your state to inform the public that you will provide translation or
 interpretation services, posted on a practice website and in significant publications and communications. OCR provided the following sample tagline: "ATTENTION: If you speak [insert language],
 language assistance services free of charge are available to you. Call
 1-xxx-xxx-xxxx (TTY: 1-xxx-xxx-xxxx)."
 - » Note that in shorter publications such as postcards and tri-fold brochures, you may use the top two language taglines and a shorter Nondiscrimination Statement instead of the full Notice of Nondiscrimination: "[NAME OF DENTAL PRACTICE] complies with all applicable Federal civil rights laws and does not discriminate on the basis of race, color, national origin, age, disability, or sex."

One of the common questions AAPD has received is how can my practice easily post notices in all 15 of the most common languages spoken in my state? The ADA has made that easy by providing state-by-state ADA sample taglines indicating that language assistance is available for patients with limited English proficiency who need interpretation or translation services. Find the top 15 languages in each state at https://www.cms.gov/CCIIO/Resources/Regulations-and-Guidance/Downloads/Appendix-A-Top-15.pdf.

Another common question is how can my practice access translation or interpretation services? Last year the AAPD announced a new endorsed, discounted services for AAPD members with Martti, who provide outstanding video and audio interpreting services. See http://www.martti.us/aapd/ for more information.

The AAPD also continues to support ADA's efforts for repeal of Section 1557 regulations.

Title VII Health Professions Training Program for Pediatric Dentistry

HRSA Awards 10 Pediatric Dental Faculty Loan Repayment Grants

The AAPD was pleased that the federal Health Resources and Services Administration (HRSA) awarded 10 dental schools or pediatric dental residency programs grants for faculty loan repayment. Thanks to AAPD advocacy efforts that obtained both FY 2017 federal funding and favorable Congressional report language, \$884,000 in total was awarded with a preference for pediatric dental faculty members. The loan repayment program extends for five years, repaying a higher amount each year so long as the benefitted individual remains a full-time faculty member. Preference in making grant awards was given to applicants providing loan repayment to pediatric dentistry faculty supervising residents at dental training institutions providing clinical services in dental clinics located in dental schools, hospitals, or community-based affiliated sites.

The 10 awardees were:

- Loma Linda University (Loma Linda, Calif.)
- Howard University (Washington, D.C.)
- Augusta University (Augusta, Ga.)
- Nicklaus Children's Hospital of Miami (Miami, Fl.)
- University of Illinois-Chicago (Chicago, Ill.)
- University of Minnesota (Minneapolis, Minn.)
- University of Mississippi (Jackson, Miss.)
- Bronx-Lebanon Hospital (New York, N.Y.)
- Children's Hospital of Cincinnati (Cincinnati, Ohio)
- University of Tennessee (Memphis, Tenn.)

Each awardee program will administer the loan repayment and identify the individual recipient(s) of such funds. All 10 awardees met the preference for pediatric dental faculty.² The institutions will use grant funds to pay an amount equal to 10, 15, 20, 25, and 30 percent of the student loan balance, upon completion of each year of service. See the profiles of one of the recipients in the education training programs section of this report.

HRSA Awards 13 Predoctoral Pediatric Training in General Dentistry and Dental Hygiene Grants

In the fall of 2017 HRSA awarded 13 grants to dental education institutions to enhance clinical predoctoral dental and dental hygiene training focusing on children ages 0-5 to improve the oral health of vulnerable, underserved, and rural pediatric populations. Thanks to AAPD advocacy efforts that obtained FY 2017 federal funding, HRSA allocated \$4.4 million for this competition, which includes a small childhood obesity prevention supplement. These are five-year awards, with up to \$300,000 available per grantee per year.

AAPD Pleased with Pediatric Dentistry Funding in FY 2018 House Labor-HHS-Education Appropriations Bill

On July 19, 2017, the House Appropriations Committee approved the FY 2018 Labor-HHS-Education Appropriations bill by a 28-22 vote. The committee report indicates that the bill provides \$237 million for Title VII health professions training, a \$72.2 million (23.3 percent) cut, and provides \$211 million for Title VIII nursing programs, an \$18.3 million (eight percent) cut. Fortunately, Title VII oral health training programs fared well, with pediatric dentistry receiving level funding of \$10 million, along with a continued commitment to the dental faculty loan repayment program. The following funding level and favorable report language sought by AAPD, ADA, and ADEA was included (emphasis added):

"Oral Health Training

The Committee recommends \$36,673,000 for Oral Health Training programs, which is the same as the fiscal year 2017 enacted level and \$36,673,000 above the fiscal year 2018 budget request . . .

Within the funds provided, the Committee includes not less than \$10,000,000 for General Dentistry Programs and not less than \$10,000,000 for Pediatric Dentistry programs. The Committee directs HRSA to provide continuation funding for pre-doctoral and postdoctoral training grants initially awarded in fiscal year 2015. Within the funds provided, the Committee

provides not less than \$1,675,000 for the Dental Faculty Loan Repayment program authorized by section 748 of the Public Health Service Act. The Committee directs HRSA to provide continuation funding for grants initially awarded in fiscal years 2016 and 2017." (pp. 22-23)

The Senate L-HHS-Education Appropriations Subcommittee approved its version in early September, 2017 as S. 1771 and Sen. Report 115-150. This contained similar report language and the same funding level for Title VII primary dental care programs as the House bill.

We acknowledge the efforts of Congressional Liaison Dr. Heber Simmons Jr. and the firm of Hogan Lovells in obtaining this outcome. The AAPD also thanks all members who advocated for this funding during the 2017 AAPD Public Policy Advocacy Conference in Washington, D.C. After a series of Continuing Resolutions to keep the federal government running, the final Omnibus FY 2018 funding bill was approved by Congress and increased Title VII oral health funds by \$4 million to \$40.67 million overall.

Chief Dental Officer Position at CMS

On Dec. 15, 2017, the AAPD along with the ADA and the Organized Dentistry Coalition wrote a letter to CMS requesting appointment of a new Chief Dental Officer (CDO) despite a federal hiring freeze. Dr. Lynn Mouden stepped down as CMS CDO last summer. Slightly before that Laurie Norris, Senior Policy Advisor for Oral Health, also left CMS. The AAPD is seriously concerned about a leadership void in oral health expertise at the agency. The letter to Eric D. Hargan, acting secretary of the U.S. Department of Health and Human Services, asked the agency not only to fill the vacant position, but also to prioritize oral health services in a manner equal to medical services.

State Public Policy Advocate (PPA) Initiative

The AAPD through the Council on Government Affairs (CGA) initiated a state Public Policy Advocate initiative in 2012 to strengthen and coordinate state-level advocacy efforts by our state chapters. The PPA serves as the state pediatric dentistry chapter's advocate for the oral health issues of infants, children, adolescents and patients with special health care and developmental needs. The PPA represents the chapter in promoting children's oral health issues with the state legislature and other elected bodies, state regulatory agencies (including Medicaid and health departments), licensing bureaus, professional health and child welfare organizations, oral health coalitions, foundations, institutions of dental education, publicly-funded safety net programs, and the private sector benefits industry. The PPA also closely coordinates their activities with those of the state dental association. PPAs serve as an advocacy liaison between the state pediatric dentistry chapter and the state dental association.

We continue to convene PPA quarterly conference calls to share information and discuss strategy. See written reports from PPAs in your annual session council and committee reports (available on the AAPD website).

Below are some examples of PPA efforts over the past year:

Minnesota Medicaid Dental Program Fee Increase

Minnesota PPA Dr. Elise Sarvas reported that the Minnesota state legislature approved a 23.8 percent fee increase for pediatric FFS patients, effective July 1, 2017. Sarvas indicates that it's a step in the right direction that begin to dig Minnesota out of the inglorious last-place position in terms of Medicaid dental reimbursement. This was spurred in part by a May 1, 2017, letter sent by CMS to Minnesota warning that the state did not adequately cover dental care for children on Medicaid. Only 37 percent of Minnesota children on Medicaid had any type of preventive dental care in 2015, far below the national average of 46 percent. An improvement plan from the state was requested within 90 days. Unfortunately the increase only impacts non-managed care Medicaid plans, meaning it impacts about 20 percent of families covered by Medicaid in the state.

Nebraska EFDA Legislation

Nebraska PPA Dr. Holly Portwood reported that the state legislature unanimously passed an expanded duties bill (LB 18) for dental assistants and hygienists. This was a 10 year effort with support of the Nebraska Academy of Pediatric Dentistry, the Nebraska Dental Association, the state board of dentistry, and the AAPD. She indicated this bill improves the efficiency of dental care while keeping the dentist the head of the dental team. Among the bill's provisions, upon completion of education and testing approved by the board and with a permit from the department for the respective competency, an expanded function dental assistant (EFDA) may place, under the indirect supervision of a licensed dentist: restorative level one simple restorations (one surface); and restorative level two complex restorations (multiple surfaces). Dr. Portwood noted the licensed dentist supervising a dental assistant, a licensed dental assistant, or an expanded function dental assistant shall be responsible for patient care for each patient regardless of whether the patient care is rendered personally by the dentist or by a dental assistant, a licensed dental assistant, or an expanded function dental assistant.

Washington State Medicaid Audit Reform Legislation

Washington State PPA Dr. John Gibbons reported that the state legislature approved a Medicaid audit reform bill (Substitute House Bill 1314). Modeled after many provisions in a 2015 Nebraska law, among various provisions the bill would require:

- Thirty days' notice before scheduling any on-site audit, unless there is evidence of danger to public health and safety or fraudulent activities.
- Reasonable effort to avoid reviewing claims that are currently or have already been audited by the state Medicaid program.
- Any finding based upon extrapolation and related sampling must be established to be statistically fair and reasonable.
- Overpayments may not be recouped until all informal and formal appeals processes have been completed.
- In any appeal, the auditor must employ or contract with a medical or dental professional who practices within the same specialty, is board certified, and experienced in the treatment, billing and coding procedures used by the provider being audited.
- The state shall provide education and training programs annually for providers, including a summary of audit results, a description of common issues, problems and mistakes identified through audit and review, and opportunities for improvement.

Specialty Advertising Regulations

AAPD is working closely with PPAs and their state chapters to promote reasonable state dental board regulation of specialty advertising announcements. In March of 2018 the AAPD submitted a joint letter comment letter with the Washington State Academy of Pediatric Dentistry to the Washington State Dental Quality Assurance Commission, and a joint comment letter with the Iowa Academy of Pediatric Dentistry to the Iowa Dental Board. The letters were written in response to consideration of regulatory changes to either expand the definition of a dental specialty or delete specialty advertising criteria altogether. These letters highlight the unique nature of pediatric dentistry as the only age-defined dental specialty, and urge the dental boards to fulfill their duties to prevent confusion for parents/guardians as to whether or not a dentist is trained as a pediatric dentist. AAPD on the Web (www.aapd.org, mychildrensteeth.org and pediatricdentistrytoday.org)

The AAPD website continues to provide information and resources to assist its members in advocating guidelines and programs that advance the oral health of all children, including those with special health care needs. In addition to providing information to its members, the website also provides tools and resources for parents to encourage good dental health habits to share with their children.




FIGURE 1: USERS AND SESSIONS BY YEAR*




FIGURE 2: COUNTRIES THAT ACCESS THE AAPD WEBSITE*

In 2017, we saw nearly an 8.6 percent increase in the number of sessions, meaning visits to the AAPD website (Figure 1). This had a lot to do with the redesigned annual session webpages for AAPD 2017. In addition to the 8.6 percent increase, the average user spent close to 1.5 minutes on each page which is an increase from the past few years. Pageviews also went up in 2017 by 7.5 percent. Another interesting finding in 2017 was that the information on the *aapd.org* website was being accessed in over 200 countries (Figure 2). This improvement is remarkable and reflects that the website gets the best, most appropriate information to visitors as quickly and easily as possible, ensuring they return again and again.

During 2017, the top pages visited on www.aapd.org were: AAPD Homepage, Oral Health Policies & Guidelines, Annual Session Homepage, Residency Programs and Publications.

In addition to the AAPD member website, AAPD has two other websites. *MyChildrensTeeth.org* was launched in 2012 to educate parents and caregivers about AAPD policies and recommendations in features catering to the layperson. *PediatricDentistryToday.org* was also launched in 2012, as an online version and archive of *Pediatric Dentistry Today* magazine.

This is thanks in part to the Mouth Monsters website (mouthmonsters.mychildrensteeth.org) that hosts lots of activities for pediatric dentists, parents and kids to learn more about dental care in a fun way. During the 2017 calendar year, we created several activities on the website such as tips on how to start the school year off strong, recipes for healthy Thanksgiving treats, and a quiz to help Santa pack his sleigh. These activities have performed very well on the website and have also reached a social media audience that averages around eight thousand people for each post. We are looking forward in creating more and more fun content to share with our members and followers in the near future.

Support for Educational Programs

There are a number of exciting initiatives to support and enhance our pediatric dentistry residency training programs, as well as pediatric dentistry in the dental school/predoctoral curriculum.

AAPD/HSHC Master Clinician Scholarship

To address the critical shortage of clinical and dental school faculty, the AAPD and HSHC established its Master Clinician Scholarship in 2008. For the tenth consecutive year, the AAPD and HSHC has provided scholarships to our members to participate in the ADEA/AAL Institute for Teaching and Learning (ITL) as well as receiving complimentary registration to Comprehensive Review of Pediatric Dentistry. **The class of 2017 consisted of six AAPD scholarships for a total of 58 ITL scholars since 2008.** The ITL is an intense professional development program created for early and mid-career dental faculty and private practice dentists interested in transitioning to an academic career. The overall program goal is to help participants refine teaching skills to enhance the quality of their interactions with students and to develop other skills that facilitate confidence, job satisfaction and professional growth in the academic environment.

The University of Tennessee College of Dentistry has a rich heritage of alumni who became leaders in Pediatric Dentistry as well as organized dentistry. This traces back to faculty who were role models of service, commitment to the patient first and clinical excellence. The challenge going forward is replacing those icons. In 2016 the average age of the faculty in the Department of Pediatric Dentistry was 64 yrs. This is not unique to the University of Tennessee. Over time residents have been identified with teaching gifts and leadership skill; who would be interested in dental education if it were not for the mountain of student debt. The HRSA Dental Faculty Loan Repayment program has enabled the identification and recruitment of such a person in **Dr. Jennifer Fernandez**, who tells the following story:



"I graduated from the University of Tennessee's pediatric dental residency in 2016. While under the mentorship of Martha Wells and Larry Dormois I discovered an affinity for teaching, but due to the heavy burden of student debt I was forced into private practice. I moved away after graduation to work and due to life circumstances, found myself back in Memphis. The Dental Faculty Loan Repayment Program allowed me to both enjoy a life of teaching and comfortably repay my student loans. Were it not for the faculty loan repayment half of my take home pay would go toward debt repayment, which would preclude the faculty position. The freedom it has given me to pursue this field of work is without measure, and for that I am truly grateful."

International Association of Dental Research (IADR) and The American Association of Dental Research (AADR)

The AAPD continues to support and collaborate with the Pediatric Oral Health Research and Scientific Group (POHR) within IADR / AADR. Dr. Rebecca Slayton, UW Professor Emeritus and president-elect of the Section has been assisting the current president Dr. David Manton from the University of Melbourne (AU) throughout the year. AAPD member Kimon Divaris from the University of North Carolina continues to serve as group program chair, and AAPD member Donald Chi from the University of Washington continues to serve as the Proposal Coordinator and organizer for symposium, lunch and learn and hands-on workshops. AAPD staff serve as the assistant secretary and assistant treasurer of the group.

The Society for Pediatric Sedation and Dartmouth University Informatics

The AAPD is engaged in collaboration with the Society for Pediatric Sedation and Dartmouth University Informatics to develop a national data base to build a data base about sedation activities in pediatric dentistry. Currently six residency training programs are participating in a pilot program tracking sedation activities. It is anticipated that data collected will be used to reinforce the safety and efficacy of sedation in the dental office, influence policy makers and provide accurate information to the public and press.

Pediatric dentists are the most generous professionals in all of dentistry. Nearly 80 percent of AAPD members provide some form of pro bono dental care in the United States AND one-third of AAPD members have contributed to Healthy Smiles, Healthy Children at least once in the last four years.

Driven by this generosity and Healthy Smiles' mission to promote initiatives providing Dental Homes for all children, the Healthy Smiles, Healthy Children's board of trustees began charting a course to help our grantees provide dental homes to one million children by June 2022.

In collaboration with the National Network of Oral Health Access, we've begun a trial outcomes tracking protocol with our six current Multi-Year Access to Care Grant recipients. This effort began in March 2018 and will allow Healthy Smiles and participating grantees to monitor and compare their progress.

Broadening our Reach

HSHC is expanding grant making efforts through a variety of initiatives while pursuing our 1 million-child goal. This includes identifying pilot opportunities around the country that will help us help grantees provide much-needed care to underserved children and pursuing opportunities that also help raise the national understanding of the importance of child oral health.

Brief Update on the American Board of Pediatric Dentistry

I am pleased to report that the AAPD maintains an excellent workshop relationship on both the volunteer and staff level with our specialty's certifying board, the American Board of Pediatric Dentistry. Since 1964, the AAPD has sponsored the American Board of Pediatric Dentistry (ABPD), fulfilling a requirement that to be recognized as a specialty an organization must demonstrate the ability to establish a certifying board (CDEL/ADA 2001). As the credentialing and certifying arm of the specialty, ABPD has a vision that we support:



To achieve excellence in pediatric dentistry through certification of all pediatric dentists.

As of this writing, 5,566 pediatric dentists are board certified, which represents more than 78 percent of eligible AAPD members. There are another 762 active candidates and 600 active applicants in the certification process. **This is a tremendous achievement for the ABPD and for the profession of pediatric dentistry!**

The AAPD works closely with the ABPD Executive Director Dr. Jeffrey Dean. The AAPD leadership and my office continues to support ABPD's efforts to encourage all Academy members to be certified and to enroll in the renewal of certification process.
