AAPD Names New Board Officers and Trustees at Virtual Annual Session

CHICAGO (May 24, 2020) — The American Academy of Pediatric Dentistry (AAPD), the leading authority on children's oral health, inducted the new president and other officers and trustees for the new AAPD board of trustees on May 24, 2020.

Jessica Y. Lee, D.D.S., M.P.H., Ph.D., President. Lee is the Demeritt Distinguished Professor and Chair of the Department of Pediatric Dentistry at the University of North Carolina. She is also a Professor in the Department of Health Policy and Management in the Gillings School of Global Public Health at the University of North Carolina at Chapel Hill. She received her M.P.H. and D.D.S. degrees from Columbia University and her certificate in Pediatric Dentistry and Ph.D. in Health Policy and Management from the University of North Carolina at Chapel Hill where she was also a NIDCR National Research Service Award recipient. She is a board certified pediatric dentist and an active member of the medical staff at UNC Hospitals, and practices in the Dental Faculty Practice in the School of Dentistry. She has authored over 100 peer-reviewed manuscripts, abstracts and book chapters. She is involved in teaching, clinical practice and research, and maintains several funded research grants. Her primary research interests are in infant oral health, access to dental care for young children and health services. Lee is the recipient of numerous teaching and research awards including the 2008 AAPD Jerome Miller "For the Kids" Award. In 2010, she received the Presidential Early Career Award for Scientist and Engineers from President Barack Obama. In 2011, she was named the "Pediatric Dentist of the Year" by the AAPD.

K. Jean Beauchamp, D.D.S., President-Elect. Beauchamp is a board certified pediatric dentist who is a private practitioner in Clarksville, TN. She earned her D.D.S. degree from the University of Tennessee (UT) Health Science Center in Memphis. She then completed her pediatric residency also at UT in 1993. Beauchamp is very involved in local, state and national dental societies. She has been active with the AAPD serving on the Board of Trustees as Parliamentarian and Southeastern District trustee. She was also the chair of the AAPD's . Council on Communications, the Political Action Committee Steering Committee and the Committee on Interprofessional Relations. She has served on the American Dental Association's Council of Government Affairs and also was a member of the Council on Access, Prevention and Interprofessional Relations and ADA's representative on an Advisory Committee of the Joint

Commission on Accreditation of Healthcare Organizations. She is a graduate of the AAPD Leadership Institute at the Kellogg School of Business and the AAPD Advanced Leadership Institute at the Wharton School of Business. Beauchamp is a fellow in the International College of Dentists, the American College of Dents and the Pierre Fauchard Academy. Beauchamp is also active with the Tennessee Dental Association, currently serving as President. She has been a Tennessee delegate to the ADA House of Delegates for 14 years.

Amr Moursi, D.D.S., Vice President. Moursi is Professor and Chair of the Department of Pediatric Dentistry at the New York University College of Dentistry and on the Medical Staff at the New York University Langone Medical Center and the Bellevue Hospital Center in N.Y. He completed his D.D.S. degree at the University of Michigan School of Dentistry, a pediatric dentistry residency at Children's Hospital of Pittsburgh and then a Ph.D. in Craniofacial Biology from the University of California at San Francisco. He is a board-certified Diplomate of the American Board of Pediatric Dentistry. For the AAPD, he currently serves as a Fellow of the Pediatric Oral Health Research and Policy Center, Director of the Comprehensive Review Course, on the Editorial Board of the Journal of Dentistry for Children, and also as a National Spokesperson. He received the Merle S. Hunter Leadership Award, and has been selected for the AAPD Leadership and Advanced Leadership Institutes. In his other service activities, Moursi serves as an Examiner for the Royal College of Surgeons in Ireland and as a consultant to both the New York State and New York City Departments of Health. His research focuses on early childhood oral health. He is the author or co-author of over 100 published articles, book chapters and policy briefs. He is also Editor of the textbook "Clinical Cases in Pediatric Dentistry, 2nd Ed." (Wiley-Blackwell). Moursi is Host of the Dental Health Show on Doctor Radio, SiriusXM satellite radio. He also maintains a private practice in New York City.

Scott W. Cashion, D.D.S., M.S., Secretary-Treasurer. Cashion is a graduate of the University of North Carolina School of Dentistry and finished his Residency and Masters in Pediatric Dentistry there in 1997. He is currently an adjunct faculty member in the Department of Pediatric Dentistry. He is a board-certified pediatric dentist and a Diplomate of the American Board of Pediatric Dentistry. Cashion currently serves as the chair of the Pediatric Medicaid/CHIP Advisory committee and is President of the Medicaid/Medicare/CHIP Services Association (MSDA). Dr. Cashion served on the Board of Trustees of the AAPD from 2008-2011 and was Parliamentarian from 2012-2013. He was awarded the AAPD's Merle C. Kevin Donly, D.D.S., M.S., Immediate Past President. Donly is currently a Professor and Chair of the Department of Developmental Dentistry and Professor in the Department of Pediatrics at the University of Texas Health Science Center at San Antonio. He received his D.D.S. in 1984, certificate in pediatric dentistry in 1986, and M.S. in 1986 from the University of Iowa. He is board certified in pediatric dentistry. Previous positions include Professor and Associate Director of the Center for Clinical Studies at the University of Iowa, Associate

Professor, Pediatric Dentistry at the University of Texas Dental Branch at Houston and Associate Professor, the University of Texas Medical School. He served a four-year term as the Pediatric Dentistry Commissioner for the Commission on Dental Accreditation. He has published over 350 chapters, manuscripts and abstracts associated with pediatric dentistry and dental restorative materials research and clinical utilization.

Gila C. Dorostkar, D.D.S., Parliamentarian.
