



This exciting session will offer busy clinicians an update on the current concepts and innovative approaches in diagnosis, management and treatment of dental trauma in children and adolescents. The format will feature a review of up-to-date fundamentals and emerging approaches most to be illustrated by case reviews. Hear from a group of internationally recognized expert speakers in dental trauma. Using the best evidence, we will discuss avulsion therapy from A to Z and bring participants up-to-speed with new concepts in avulsion care. The concept of decoronation and pulp regeneration will be presented and illustrated with clinical cases. Participants will also learn the best operative and orthodontics techniques to achieve optimal esthetic results. Be sure to plan on staying for the afternoon when the exciting area of tooth autotransplantation in children will be presented.

Upon completion of this course, attendees will be able to:

- Up-to-date science in the area of diagnosis for the permanent tooth in children and adolescents
- Fundamentals of pulp regeneration.
- How and when to perform decoronation.
- Operative and orthodontics techniques to achieve optimal esthetic results.
- The emerging area of tooth autotransplantation.



## Did You Know?

There are few details of the tooth fairy's appearance. Approximately 75 percent of people believe the tooth fairy to be female. Descriptions include the Tinkerbell-type fairy with wings, wand etc., but some describe the tooth fairy as a man, a bunny rabbit or a mouse. In Italy, Fatina dei denti, the tooth fairy, has a helper called Topolino dei denti – a mouse who collects the teeth for her! In Indian, China, Japan, Korea, and Vietnam, children throw their teeth. More specifically, bottom teeth are tossed up toward the sky and upper teeth are tossed down to the floor.

Evidence-based clinical practice guidelines are based on well-done systematic reviews while assessing the certainty of evidence and balancing benefits and harms to patients' values and preferences. Such guidelines are considered trustworthy and can be used by the clinicians to provide the highest quality patient-centered care in their practices. The AAPD published a clinical practice guideline on primary teeth non-vital pulp therapies in 2020 and is updating the 2017 clinical practice guideline on primary teeth vital pulp therapies and developing a permanent tooth vital pulp guideline. This session will explain AAPD's pulp therapy guidelines from a clinician's perspective and evaluate in-depth the basis and interpretation of the evidence-based findings for vital and non-vital pulp therapies in teeth.

This year he was the first author of A Systematic Review and Meta-Analysis of Nonvital Pulp Therapy for Primary Teeth published in *Pediatr Dent* 2020;42(4) and the Guideline, Use of Non-Vital Pulp Therapies in Primary Teeth, also published in 2020 in *Pediatr Dent* 2020;42(5).



**Vineet Dhar** is a professor and department chair of Orthodontics and Pediatric Dentistry and graduate program director of Pediatric Dentistry at University of

Maryland School of Dentistry, Baltimore, Md. A board-certified pediatric dentist, he serves on the Councils on Scientific Affairs and Post-doctoral Education of the American Academy of Pediatric Dentistry, on the Scientific Committee of International Association of Paediatric Dentistry, and on the Council of Scientific Affairs, American Dental Association as the Chair of Clinical Excellence subcommittee. He currently serves on the ADA guideline panels on restorative care, caries prevention, and has in the past served on the pit and fissure sealants panel. **170. Speed Learning, Back to Basics: Restorative Principles & Materials**

Composite resins and glass-ionomer cements were introduced to dentistry in the 1960s and 1970s, respectively. Since then, there has been a series of modifications to both materials as well as the development other groups (bioactive) claiming intermediate characteristics between the two. Combined with multiple adhesive strategies, the result is a confusion of materials leading to selection problems. While these materials are tooth-colored, there is a considerable difference in their properties, and it is important that each is used in the appropriate situation. Composite resin materials are esthetic and now show acceptable physical strength and wear resistance. However, they are hydrophobic, and therefore more difficult to handle in the oral environment and cannot support ion migration. On the other hand, glass ionomers are water-based and therefore have the potential for ion migration, both inward and outward from the restoration, leading to several advantages. However, they lack the physical properties required for use in load-bearing areas. This presentation is intended to update the classification, material selection, and material application so that the clinician can make an appropriate and evidence-based choice when selecting a direct restorative material for any given situation.

- Update the classification of tooth-colored restorative materials (including newly introduced bulkfill composites and bioactive materials) so that clinicians can make an appropriate, evidence-based choice

when selecting a direct restorative material for any given situation.

- Provide clinical tips to maximize the potential and longevity of direct restorations.



**Taiseer Sulaiman** is the director of the Advanced Operative Dentistry and Biomaterials Research at the Adams School of Dentistry, University of North

Carolina at Chapel Hill where he earned his clinical certificate in Operative Dentistry and his Ph.D. in Dental Materials from the Department of Prosthetic Dentistry and Biomaterial Sciences from the University of Turku in Finland in collaboration with the Department of Operative Dentistry at UNC. Sulaiman is a wet-handed clinician, and a researcher who is passionate about bridging the gap between dental research and clinical application. Sulaiman's research focus is on dental ceramics, adhesion, cements, color and appearance in dentistry and biomimetics. He has published over 75 peer-reviewed articles, abstracts, and book chapters. He is a member of many academies including the Academy of Operative Dentistry (where he serves as councilor to the academy), the Society of Color and Appearance in Dentistry, IADR/AADR, and the American Dental Association. He has lectured on numerous national and international stages and serves as a reviewer for many peer-reviewed journals.



**J. Timothy Wright** received his D.D.S. degree from West Virginia University and completed his specialty training in pediatric dentistry and Master of Science

Degree at the University of Alabama at Birmingham. He currently is the Distinguished Bawden Professor in the Department of Pediatric Dentistry, The University of North Carolina, Chapel Hill

and has served as Pediatric Dentistry Department Chair. He is a Diplomate of the American Board of Pediatric Dentistry and a Fellow of the American Academy for the Advancement of Science. He has published over 200 peer reviewed scientific manuscripts, edited two texts and authored 24 text chapters. Dr. Wright has served as the Chair of the Council for Scientific Affairs for the American Academy of Pediatric Dentistry and the American Dental Association. He continues to serve on the AAPD Council for Scientific Affairs and is the current Chair of the AAPD - Evidence Based Dentistry Committee. Liu holds leadership positions in the Society for Developmental and Behavioral Pediatrics (SDBP) and the American Academy of Pediatrics. Her work has appeared in the Journal of Developmental and Behavioral Pediatrics, Rudolph's Pediatrics, Nelson Essentials of Pediatrics, The Zuckerman Parker Handbook of Developmental and Behavioral Pediatrics for Primary Care, and The Child, An Encyclopedic Companion. Liu's clinical and academic interests include inter-professional collaboration and systems of care for children with developmental delays and disabilities and behavioral and mental health conditions.



**Anupama Rao Tate** is an associate professor of pediatrics at the George Washington University School of Medicine. She is a faculty

The AHA's PEARs (**Pediatric Emergency Assessment, Recognition and Stabilization**) Course has been updated to reflect science in the 2015 AHA Guidelines for CPR and ECC.
