



100. Speech and Language in a Developing Child

The presentation explores the interaction of pediatric dentistry and Speech Language Pathology (SLP) with an attempt to clarify the confusing picture of speech disorders from the pediatric dental perspective and decode some of the speech-language specific terminology. A discussion of common dental malocclusions and interventions for their correction on speech will be discussed. The responsibilities of a pediatric dentist with regards to speech disorders, behavioral rules and aids for interacting with, and counseling, children with speech disorders will be presented. How to interact with and work cooperatively with speech language pathologists in the interest of mutual patients/clients will be discussed.

The session will also outline the normal development of language and speech. Particular emphasis will be placed on the different subsystems of speech production and the associated anatomy. Methods for the assessment of speech production will be described.

Gahanan Kulkarni is a tenured associate professor of dentistry at the University of Toronto since 1998. He is a diplomate of the American Board of Pediatric Dentistry and a fellow of the Royal College of Dentists of Canada. With over 150 publications and presentations, he is a regular presenter at the AAPD and IAPD meetings.

Paula Klaiman began her career at SickKids in 1985. She is the senior Speech-Language Pathologist on the Cleft Lip/Palate, Craniofacial and 22q Deletion Syndrome teams and an assistant professor in the Graduate Department of Speech-Language Pathology at the University of Toronto. She has taught courses to Speech-Language Pathology, dental and medical students. Klaiman has lectured extensively on the assessment and treatment of communication disorders in children with cleft palate and craniofacial conditions. Her main research focus is on clinical outcomes following surgery for Velopharyngeal Dysfunction. Klaiman has published numerous articles and several book chapters related to her area of expertise.

Tim Bressmann is an associate professor in the Department of Speech-Language Pathology at the University of Toronto. Hearing the term government audit is sufficient to strike fear in the heart of any practicing pediatric dentist. However, it is important to understand the basis for and scope of government auditing authority in two critical areas: dental insurance for children of low-income families (Medicaid) and patient privacy (the Health Insurance Portability and Accountability Act of 1996, known as HIPAA). Legal and government experts will examine the legal and regulatory framework within the Medicaid and HIPAA laws and steps that a pediatric dental practice should take to ensure compliance with these laws. This presentation will discuss various types of audits, the auditing process, and steps a provider should take during an audit. Finally, recommendations will be made for obtaining a positive audit outcome.

Jessica Meeske practices in south central Nebraska where she is a partner with Pediatric Dental Specialists of Greater Nebraska. Meeske is a graduate of Hastings College and the University of Missouri-K.C. College of Dentistry. She completed further training in pediatrics and public health at the University of Iowa, College of Dentistry's, Leadership in Pediatric Dentistry and Dental Public Health Program where she received her master's in dental public health. Meeske is board certified by the American Board of Pediatric Dentistry. She serves on the AAPD board of trustees.

Margaret Surowka Rossi has more than 20 years of experience as a strong advocate for her health care clients, representing individual providers and facilities in licensure, disciplinary and ethics proceedings. She routinely counsels clients who are faced with Medicaid, Medicare and other governmental investigations and audits, as well as on employment and contract matters. Paula Tironi is a senior associate general counsel in the American Dental Association Division of Legal Affairs. She concentrates on health law and data security issues, including HIPAA and federal health care regulations, and serves as an attorney liaison to the ADA Council on Scientific Affairs, the Commission on Continuing Education Provider Recognition, and the Strategic Planning Committee. Paula previously worked as Corporate Legal Counsel to manufacturing corporation Armstrong International, Inc.

Lynn Mouden is an internationally recognized author and lecturer on the clinical and legal aspects of family violence prevention and oral health advocacy. He earned his undergraduate degree from the University of Kansas; his D.D.S., with distinction, from the University of Missouri at Kansas City; and his Masters in Public Health from the University of North Carolina. 140. Sedation: What's New? Local Anesthesia Review and What's New

Local anesthetics and their associated vasoconstrictors have had a long history of safety and efficacy in dental practice. However, pediatric dental patients are especially vulnerable to overdose reactions with this group of drugs, and it is criti-

cal that the clinician does not exceed maximum recommended dosages of these agents. These important dosage calculations and an introduction to "The Rule of 25" will be discussed. Kovanzaze, an intranasal spray formulation of three percent tetracaine

plus 0.05 percent oxymetazoline received FDA approval on June 29, 2016, to provide maxillary anesthesia for a single restorative procedure from 2nd premolar to 2nd premolar, and in all primary teeth without the need for a conventional injection in patients weighing at least 88 pounds. This appears to be a useful addition the to pediatric dentist's local anesthesia armamentarium in fearful children, and evidence-based research performed by the speaker and others supporting the efficacy and safety of this formulation will be highlighted. Finally, evidence-based research concerning the ability of Oraverse (phentolamine mesylate) to safely accelerate the recovery of soft tissue numbness in adults and children as young as three years of age will also be presented.

It comes as no surprise to the pediatric dentist that sedation-related morbidity and mortality is a frequent topic of discussion in today's media. Regardless, it is of the utmost importance to identify high risk patients and ensure an adequate emergency armamentarium is in the office. In the wake of such events, state boards may opt to increase monitoring requirements as well. This lecture will review ADA and AAPD Guidelines, including end-tidal capnography; novel oxygen and nitrous oxide delivery systems; and emergency armamentarium, including reversal agent dosing and EpiPen® auto injector alternatives.

Elliot Hersh is currently a professor of Pharmacology/ Oral Surgery at the University of Pennsylvania School of Dental Medicine. He received his D.M.D. degree from UMDNJ-NJDS in 1981 and his M.S. and Ph.D. degrees from UMDNJ - Graduate School of Biomedical Sciences in 1983 and 1988 respectively. Since arriving at the PENN in 1988, Hersh has won the Dental School's Excellence in the Teaching of Basic Science Award 20 different times and was also presented with a University Lindback Award in 1993, the highest teaching honor in the entire university. In October 2016, Hersh was the recipient of the University of Pennsylvania One Health Award for his collaborative efforts with faculty from the Schools of Nursing and Medicine in establishing an NIH-funded Center of Excellence in Pain Education. He has published more than 150 scientific articles, abstracts and book chapters in the areas of dental pharmacology, drug interactions, analgesics and local anesthetics. His scholarly and research contributions in the areas of local anesthesia and pain control were recognized by the International Association of Dental Research in 2007 when he was presented with the Distinguished Scientist Award in Pharmacology, Therapeutics and Toxicology.

Mana Saraghi is a board-certified dentist anesthesiologist. She is the dental anesthesiology residency program director at Jacobi Medical Center, Bronx, N.Y.; attending dentist anesthesiologist at SBH Health System, Bronx, N.Y.; and clinical assistant professor at the Herman Ostrow School of Dentistry of the University of Southern California in Los Angeles, Calif. Saraghi maintains a private practice in which she focuses on providing pain and anxiety control for dental patients, including pediatric, adult, geriatric, and special needs patients. Some young children benefit from interceptive orthodontic treatment. This treatment may include eruption guidance of the permanent teeth, control of habits, cross bite correction, and management of crowding in the mixed dentition. Orthopedic correction of skeletal discrepancies may also be accomplished in the young, growing patient. The practitioner should

be able to recognize these potential patients and be familiar with viable treatment options. Most importantly, the skilled clinician must determine when such Phase I treatment is beneficial and defendable.

210. Combating Caries with Silver Diamine Fluoride—When, Why, and **How to Get SMART**

Dental caries, the most prevalent disease in humans, affects 97 percent of the population in their lifetime. Yet, dental professionals are still primarily using >100 year-old technologies to assess and manage this most prevalent infectious disease.

Recently, new ways of assessing and dealing with dental caries as an infectious disease have been proposed, and new products have been introduced. It is anticipated that the progression of this most significant technological development in dentistry will do more to change the way we practice than anything in recent decades. This course will review the science behind these developments, and will introduce clinically relevant information to practitioners to prepare them to understand related new information as it is introduced to the professionals and consumers. In addition, application of these techniques to early intervention protocols including the use of silver diamine fluoride and other agents to mitigate the impact of caries will be described.

A brush-on liquid called Silver Diamine Fluoride (SDF) has the potential to become the first drug for treating dental caries. It is safe, inexpensive, and simple to apply. Surveys in the U.S. show high levels of patient / parent preference compared to techniques requiring local anesthetic. With reapplication, SDF stops 80-90

percent of cavities, but not right away, and there are not clear indicators of which lesions will keep growing. Clinicians need to be prepared for the black staining and the 10-20 percent of lesions that will keep growing. This session will describe breakthroughs in the science and practice of arresting caries with SDF to interrupt the cycle of disease and restoration that occurs when the underlying problem is out of control. Early adoption has occurred in treatment of pre-cooperative children, patients with special health care needs, and older adults, but this is relevant to all patients with caries. Areas of focus include: clinical protocols, economics, integration with other caries management techniques, incorporation into restorative practice, and the evidence from clinical trials and mechanistic studies. Drs. Horst and Berg aim to build a comprehensive understanding of how the use of SDF to treat and prevent dental caries interfaces with contemporary dentistry.

Joel Berg is dean and professor of pediatric dentistry at the University of Washington School of Dentistry as well as Lloyd and Kay Chapman Chair for Oral Health. He is a diplomate of the American Board of Pediatric Dentistry and is a past president of the American Academy of Pediatric Dentistry.

Jeremy Horst is a practicing biochemist and practicing pediatric dentist. He holds a fellowship in the DeRisi and Featherstone labs at UC San Francisco, where he uses cutting edge genetics and imaging technologies to study the mechanisms of success and failure for treatment of dental caries with Silver Diamine Fluoride (SDF). Horst is presently carrying out five clinical studies incorporating medical interventions for dental caries with microbiome analyses. He has published more than 30 papers and book chapters on genetics and orofacial diseases. His research efforts earned an NIH/NIDCR NRSA, the International Hatton Award, a Warren Magnuson Fellowship, and the Ralph McDonald Award. In his practice he focuses on maximally effective, minimally invasive techniques to stop dental caries and create an easy relationship to dentistry for children and people with special health care needs. Horst recently chaired a committee that establish Guidelines on the use of SDF for caries, and has given over 40 courses on this topic since the material became available May 2015. She serves as the director of Advocacy and Research. She also is director of the District of Columbia Pediatric Oral Health Coalition. She is a Trustee and chairs the Grants and Programs Committee of Healthy Smiles, Healthy Children. She also serves on the Evidence-Based Dentistry Committee, Council of Clinical Affairs, and chairs the Consumer Review Committee of the AAPD. Currently she is President of the D.C. Chapter of the AAPD.

James L. Lukefahr is a professor in the Division of Child Abuse Pediatrics at the University of Texas Health Science Center at San Antonio. Lukefahr joined the Division in June 2007 and serves as the medical director of the Center for Miracles, which is the child abuse medical evaluation facility at the Children's Hospital of San Antonio. He previously was a professor at the University of Texas Medical Branch Department of Pediatrics in Galveston from 1996 until 2007. Lukefahr has written numerous scholarly articles on child abuse and neglect. He was appointed by Texas Governor George W. Bush to serve on the Children's Trust Fund of Texas Council from 1999 until 2001, and also served on the Texas Children's Justice Act Task Force from 2007 to 2013.



Susan Fisher-Owens is associate clinical professor of Pediatrics at the UCSF School of Medicine and Associate Clinical Professor of Preventive and Restorative Dental Sciences, UCSF School of Dentistry, in San Francisco, Calif. Clinically, she works as a primary care pediatrician and faculty preceptor. She spends the remainder of her time serving as a children's oral health advocate and researcher, working with medical providers to increase their knowledge and interventions in oral health and with dental professionals to increase their understanding and application of contextual factors to care. Her paper on "Influences on Children's Oral Health: A Conceptual Model" has led to other work being conducted to investigate and reduce oral health disparities and improve care, and "Primary Teeth," the clinical program she started to introduce oral health care into the pediatric practice setting was recognized with the Academic Pediatric Association's Health Care Delivery Award in 2011. She also serves on the American Academy of Pediatrics National Section on Oral Health.

This presentation will review an objective check list to assist in the evaluation and decision process for deciding to treat a frenum of an infant with a breastfeeding or bottle feeding problem.

Achieving Painless Injections without Topical Anesthesia

Warren Brill, D.M.D., M.S. (HYG), F.A.A.P.D.

We are classically taught to use a topical anesthetic agent applied to a dry surface for two minutes before injection. This technique can be uncomfortable for the child, as the agent can drip from the site to the tongue or pharynx, even when cotton 2x2s or suction is used to prevent this. In addition, it is difficult, if not impossible to determine the dosage of topical agent administered, increasing the chance of untoward effects, such as methemoglobinemia. The technique to be demonstrated uses a device that desensitizes the soft tissues so that the child feels little or no discomfort. It is effective on both free gingiva at the cheek side of the teeth, but also on the attached gingiva of the lingual and palate.

What is the impact on my practice of the recent resolutions, approved by the American Dental Association, for providing dental care for patients who are and/or have been chemically dependent? What are some of the oral manifestations of street drug abuse? Do I have

to take any precautions with the dental patient who is under the influence? The dental team is in a unique position providing dental care to a patient population that may be regular users or experimenting with mood altering drugs. This graphic presentation will help you identify and manage the substance abusing patient. Discussion includes the signs and symptoms of commonly abused prescription and illicit drugs.

Harold L. Crossley is professor emeritus at the University of Maryland Dental School. A native of Rhode Island, Crossley received a Bachelor of Science degree in Pharmacy from the University of Rhode Island in 1964. He later was awarded the Master of Science (1970) and doctorate degrees (1972) in Pharmacology. The University of Maryland Dental School in Baltimore awarded Crossley the D.D.S. degree in 1980. The liaison between the classroom and his part-time dental practice produced a practical approach to understanding the pharmacology of drugs used in the dental office. Crossley has co-authored a number of articles and four books dealing with a variety of topics within the field of pharmacology. Other areas of expertise include the pharmacology of street drugs and chemical dependency. He serves on the Maryland State Dental Association's Well-Being Committee, is an active member of Phi Kappa Phi, Omicron Kappa Upsilon Honorary Dental Society, the American College of Dentists, International College of Dentists, and an honorary member of the Thomas B. Hinman Dental Society. . He was the recipient of the 2008 Gordon Christensen Lecturer Recognition award presented by the Chicago Dental Society and the recipient of the 2012 Award of Distinction presented by the Academy of Dentistry International for his efforts in Continuing Dental Education. He has been a consultant for the United States Drug Enforcement Administration and other law enforcement agencies since 1974. Drawing on this unique background, Crossley has become nationally and internationally recognized as an expert on street drugs and chemical dependency as well as the clinical pharmacology of dental drugs.



If you would like to go from 2,000 hits to the most relevant 20 online resources in far less time than it takes you now, this course explains how to efficiently perform literature searches based on specific clinical questions. You will develop the necessary computer skills and find out the secrets of using PubMed, a free online index of health science literature.

Through active discussion and skills practice, you will learn how to critically evaluate published research studies and rank them according to the strength of evidence they provide, ranging from expert opinion and case studies to randomized controlled trials and systematic reviews.

A must-attend course for lifelong learners in the clinical field of pediatric dentistry. **Dr. Peter Buschang** is professor of orthodontics and director of orthodontic research at Baylor College of Dentistry. He received his Ph.D. in from the University of Texas at Austin in 1980; from 1980–1983 he was a NIDR postdoctoral fellow in the Department of Orthodontics, University of Connecticut Health Science Center; from 1983–1988 he was a FRSQ scholar in the Orthodontic section and Human Growth Research Center, University of Montreal. He regularly reviews articles for numerous journals and has served as associate editor for several journals (currently Angle Orthodontist). Buschang has published over 150 peer-reviewed articles and book chapters focusing on craniofacial growth, developmental adaptations associated with treatments, and oral-motor function. He is director of Baylor's graduate core course entitled "Research Design and Methodology".

Dr. N. Sue Seale is professor and chairman of the Department of Pediatric Dentistry at Baylor College of Dentistry, Texas A&M Health Science Center, as well as director of the advanced education program in pediatric dentistry at Baylor. She is director of dental service at Texas Scottish Rite Hospital of Children and chairman of the Department of Dentistry at Children's Medical Center of Dallas. In 2001, the AAPD named her Pediatric Dentist of the Year and also presented her with the Merle C. Hunter Leadership Award in 2003. She is Editor-in-Chief of the AAPD Journal *Pediatric Dentistry*.



Dental Home Day Turns Five

Time sure flies. While that's hardly an observation for the ages, it certainly applies to Dental Home Day. The 2017 Dental Home Day will be at Children's National Health System on Wednesday, May 24, during AAPD 2017 in Washington, D.C.

It will be our fifth annual Dental Home Day, which has been sponsored each year by Sunstar Americas, Inc. - AAPD 2016, San Antonio—The School of Dentistry at the University of Texas Health Science Center
 San Antonio upped the Dental Home Day stakes, holding the event in two locations: their new dental school
 clinic and their community-based clinic. Between both locations, UTHSCSA saw more than 200 patients!
- AAPD 2017, Washington, D.C.—We're anticipating the 2017 event will care for 100 patients the majority of whom will be special needs or medically-compromised children. It will be our first Dental Home Day held in a children's hospital.

Thanks to the generosity of Sunstar Americas, Inc., volunteers, and host clinic personnel, more than 500 children since 2013 have received care because of Dental Home Day. And 100 more will receive care on May 24.

There are many intervention events held around the country. They usually cover a day or so and they're over. Yes, these events can provide interim relief for children in need, but where do these children go after the last patient has been seen and the event pulls up stakes? Yes, some care is better than no care, but that's why Dental Home Day is a day of service and a year of care. We hope it's the beginning of a lasting patient/parent-dentist relationship.

The Two BIGGEST Problems Facing Pediatric Dentists

My name is Dr. Rhea Haugseth, and like you, I am a practicing pediatric dentist in Marietta, Georgia. Over the years, I found myself feeling very frustrated with the lack of efficient, cost-effective training available for pediatric dental assistants. In fact, there were two major problems that I continually had to deal with when hiring a dental assistant for my pediatric practice:

- They had no clinical training. Even if they had dental assistants' training, they still fell short of the unique needs of a pediatric practice.
- 2. They had no communication skills. They often did not know how to talk or act professionally or how to communicate effectively with children and their parents. Newly hired dental assistants tend to be young people who are just starting their careers. For a variety of reasons, many of them had very little people skills and life skills such as how to manage their resources or prioritize efficiently.

There was plenty of training for general dental assistants, but nothing for the pediatric field. I knew what it took to create a spectacular PDA, but frankly, I was tired of training and re-training with every new PDA.

Dealing With Problem #1

Knowing that my colleagues were also frustrated with these same challenges, I formally created the Pediatric Dental Assistant School (PDAS) in Atlanta where newly hired PDAs in Atlanta-based pediatric dental offices or those seeking a career as a pediatric dental assistant could get the training they need (for an entry-level position) in 9 weeks of training at my office in Atlanta.

Dealing With Problem #2

Although the PDA graduates were trained clinically, I realized there were other issues I needed to address; namely, teaching them the soft skills that came with working closely with children, parents, and the office staff. So I created training modules on parent/patient communication that teaches PDAs the art of effective communication in a professional setting, and specifically how to communicate and connect with children and their parents. This training can make a remarkable impact in patient/staff relationships.

I realized that the need for specialized training was universal, and pediatric dentists across the nation had to deal with these two problems regularly. "How can I help them?" I wondered. That is when I launched the Pediatric Dental Assistants Association. It not only provides the instruction and resources needed to train newly hired PDAs to quickly become a valuable and fully-functioning member of the staff, it is also a place where high-performing PDAs have been able to grow in their skills and in their careers.

The development of the Pediatric Dental Assistant School, along with the Pediatric Dental Assistant Association has been a wonderful addition to my practice. My staff truly loves these programs!

Pediatric dental offices who would like to receive more training and mentorship for their pediatric dental assistants should enroll their assistants in the PDAA.


