



100. Treatment of Vital and Necrotic Pulp on Immature Permanent Teeth

Pulp therapy aims to preserve and protect the inflamed pulp tissue from additional injury and facilitate its healing and repair while maintaining the health status of the tooth. With the advent of new biomaterials, the outcome of vital pulp therapy increased significantly with a high level of predictability. Contrarily, necrotic pulps with apical periodontitis present a clinical challenge, particularly in immature roots with short undeveloped root structures, thin dentinal walls, wide-open foramens and unpredictable disinfection, all of which will affect the long-term treatment outcome. MTA apexification remains a great treatment option for immature necrotic teeth, particularly for cases with advanced root development. Pulp revascularization exploits the full potential for tissue ingrowth toward dentin-like tissue deposition and stronger roots able to withstand fracture, mainly on teeth with poor maturation. This presentation will review the current evidence-based research for vital and non-vital therapy for the young permanent dentition and illustrate the importance of case selection to obtain positive outcome.

Upon completion of this course, attendees will be able to:

- Treat vital pulp exposures using the latest advancements on materials and techniques.
- Understand the concept of pulp revascularization for treatment of immature teeth with necrotic pulps.
- Develop the most predictable treatment plan for immature teeth with necrotic pulps to obtain a positive outcome.

Dr. Nestor Cohenca completed the endodontic program at the Hebrew University in Jerusalem cum laude and received the Best Graduate Student Award. He then served 11 years on faculty at the school while maintaining a private practice limited to endodontics. From 2003 to 2005, he served as a clinical assistant professor and coordinator of Trauma and Sports Dentistry at University of Southern California. Thereafter, Cohenca joined the University of Washington where he completed his endodontic certificate in 2008 and served as tenured professor of Endodontics and Pediatric Dentistry from 2005-2014. He served as director of Endodontics and the Multidisciplinary Traumatology Unit at the School of Dentistry, the Center for Pediatric Dentistry, and Seattle Children's Hospital. Currently he serves as affiliate professor at the University of Washington, professor at Seattle Children's hospital and maintains a private practice limited to Endodontics in Everett, Wash. He is a Diplomate of the Israel Board of Endodontics and the American Board of Endodontics. Cohenca is a Fellow of the IADT and received an honorary membership to Omicron Kappa Upsilon National Dental Honor Society. He has published more

than 75 peer-reviewed articles, 10 chapters and a new book entitled "Disinfection of Root Canal Systems: The Treatment of Apical Periodontitis". Cohenca currently serves as president of the International Association of Dental Traumatology. 150. Current Principles and Management of Anterior Supernumerary, Impacted, Ectopic and Missing Teeth

Ideal treatment of anterior tooth impaction (secondary to supernumerary teeth, trauma or ectopic development) and missing teeth (due to agenesis or trauma) aims to minimize long-term maintenance and maximize long-term esthetics. Temporary anchorage devices (TADs) and CBCT imaging now allow more teeth to be successfully disimpacted and spaces (left by missing teeth) to be closed to maintain alveolar bone and avoid prostheses. Realizing the potential of these new treatments requires directed treatment planning by pediatric dentists from the time of initial diagnosis. Clinical cases will be presented demonstrating the current interdisciplinary management of these challenging clinical problems in young patients.

Upon completion, attendees will be able to:

- List causes of anterior tooth eruption disturbances and their incidence/prevalence.
- Identify the diagnostic methods for assessment of anterior supernumerary, impacted, ectopic and missing teeth.
- Discuss the treatment options and ideal treatment timing for anterior supernumerary teeth and missing or impacted anterior teeth.

- Recognize factors associated with successful temporary anchorage device (TAD) protraction of posterior teeth to close space where teeth are lost or missing

Dr. Patricia Medland has a D.D.S. degree from West Virginia University (1977) and M.S. degrees in pediatric dentistry and orthodontics from the University of North Carolina (1982, 1988) and currently is an adjunct associate professor in orthodontics at the University of Queensland. Caries lesions continue to be managed most often using surgical approaches. While the use of silver products is not a new concept for caries management, the introduction of silver diamine fluoride (SDF) to the US marketplace in 2015 provided a new non-surgical caries management tool. The mechanism of action is thought to be a result of the compounds combined antimicrobial and remineralization properties. Based on systematic reviews of clinical trials the AAPD developed a guideline recommending the use of 38% SDF as part of a comprehensive caries management approach. This presentation will review the scientific evidence that informs this guideline for the use of silver diamine fluoride as a caries management tool.
